## **Conformation-Obedience & Conformation-Rally O Combination Awards**

The purpose of this award is to encourage dog show participants to promote their dogs as both conformation and obedience working dogs. **A large rosette and \$50.00 cash** will be presented on **Saturday, May 3, 2008**, after the conclusion of Best in Show judging. It will be awarded to the TWO dogs which have competed in both the specialty on Thursday and Rally O Trial (Friday) and/or Obedience trial # 1 on Saturday, and which has received the highest number of points.

**POINTS WILL BE CALCULATED AS FOLLOWS**

### **Obedience**

Highest QUALIFYING score in obedience trial # 1 (Saturday)..... **Maximum 200 points.**

Highest QUALIFYING score in Rally O Trial # 1 (Friday).....Maximum 100 points

### **Conformation (Regular or Altered Classes)**

Highest level attained based on the following (only the highest level of points will apply; if dog places in Group, then its lower breed points will not be counted). **Maximum 100 points**

**Best in Specialty** .....100 points

**Best Puppy In Specialty**..... 75 points

**Group 2nd** ..... 60 points

**Group 3rd** ..... 50 points

**Group 4th** .....40 points

**BOB or variety** ..... 25 points

**BOS or BOW** .....15 points

**Winners** ..... 10 points

**Any other breed placing**..... 5 points

**In the event of a tie score an Obedience Run-off will determine the winner of that award.**
