# Forbidden Plateau Obedience & Tracking club November 2021 Trial Ring Traffic Flow – COVID-19

#### MASKS MUST BE WORN INSIDE THE BUILDING.

- ➤ Upon arrival, exhibitors are to show their Covid-19 Vaccination Card or Proof of Vaccination together with ID, at the rear door of the building.
- Exhibitors may then proceed to the check in desk, located inside the building **rear door**, hand in their signed waiver form, and pick up their armband.
- ➤ Exhibitors for each class being judged are to gather in the assembly area inside the building **front door**, or outside the **front door** until the **Gate Steward** calls their armband numbers.
- 1) First dog/handler proceeds to the "on deck" area, to QUIETLY wait to be called into the ring. Treats are allowed in this area however, containers/excess treats cannot be taken into the ring area.
- 2)Once the prior exhibitor leaves the "on deck" area, the **Gate Steward** allows the next dog/handler to enter the area.
- Upon entry into the ring, exhibitors place their leash on the indicated chair.
- At the end of the judging, the exhibitor will pick up their leash and leave the ring through the exit and promptly leave the building through the **rear door.**

#### **Announcement of scores**

At the end of each level of judging, the **Gate or Ring Steward** will call qualifying teams into the building.

Teams to maintain a minimum of 2 metres physical distance.

Photos with the judge will be at discretion of the judge.

**Discipline:** Forbidden Plateau Obedience & Tracking Club reserves the right to remove any person from these trials. The Trial Chair shall have full control of this event which will be governed by the Canadian Kennel Club rules. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptlyreport to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Females In Season:** When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day periodpreceding the trial must reach the Trial Secretary on or before the date of the Trial. The entry fee, servicecharge and listing fee will be refunded.

**Non-Member Participation Fee:** Canadian Resident non-CKC members competing with a wholly owneddog cannot win an award or title unless they pay a non-member participation fee or a membership fee to the CKC. these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

**Change of Entry:** A dog may be moved from one official class to another within the same trial. A dog that has fulfilled the requirements for a title in accordance with the CKC Obedience Trial Rules, may be moved to the next level of competition. The transfer must be submitted to the Trial Secretary on the appropriate form by the owner or handler AT LEAST THIRTY MINUTES PRIOR TO THE COMMENCEMENT OF THE TRIAL, schedule permitting.

PLEASE NOTE THAT SMOKING IS NOT ALLOWED ON THE PROPERTY.

#### **Rules Governing These Trials**

- 1. Proof of Vaccination against Covid-19 must be presented in order to enter the building
- 2. A signed Covid-19 Waiver and declaration form is required and must be given to the secretary upon arrival.
- 3. Dogs must be always kept under control and on leash within the building except in the obedience ring.
- 4. Collars other than those specified in these rules are not allowed within the venue. Violation of this rule may result in removal of the dog from further competition at the trial.
- 5. Forbidden Plateau Obedience & Tracking Club will use all reasonable care to ensure the safety ofdogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to dogs, exhibitors, or patrons. The welfare of an exhibitor's child is the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children during these trials.
- 6. If for any reason beyond the control of the Club, it is impossible to open or complete the trials no refund of entry fees will be made.
- 7. Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called.
- 8. Any dog entered and received at an obedience trial must compete in all exercises of all classes inwhich it is entered, unless excused by the judge, official veterinarian, superintendent, or the trial chair.
- 9. Eligibility to enter specific obedience classes is detailed in the Obedience Trial Rules and Regulations. Entrants should review these requirements before entering the trials to ensure they are entered in the correct class. FPO&TC will not be held responsible for incorrect entries.
- 10. Every dog entered in an approved obedience trial must be one of the following: Registered with the CKC; have an Event Registration, Performance Event, or Canine Companion, number; have a Temporary Competition number if eligible for registration with the CKC; have a Miscellaneous Certification number if it belongs to a CKC listed breed.
- 11. Please keep the building and grounds clean. Please pick up after your dog.
