TEST DETAILS:

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the conclusion of each test
- Ducks will be used
- Shotguns may not necessarily be used
- Handlers should wear dark clothing
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted prior to test
- Running order is by random draw within each test level. Adjustment may be made for handlers with multiple dogs
- Recommended arrival time is ½ hour prior to the start time for each stake
- Entry limited to 25 dogs total for all tests.


