## **EVENT REGISTRATION NUMBER (ERN)**

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN). To obtain an ERN simply do the following:

1. Send a photocopy of the dog's Registration Certificate reflecting current ownership, for example, AKC Registration Certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide the CKC with your full return address to enable the ERN to be sent to you.
4. Faxed requests will be accepted. Please indicate your VISA/MasterCard number and expiry date, the card holders name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED"; however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores. **TEMPORARY COMPETITION NUMBER (\* EFFECTIVE MARCH 2, 2020)**

A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN).

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number.

Dogs may still enter CKC events until without a registration number or ERN until March 2, 2020 by marking TCN on the entry form (or Listed if it is an older entry form). An email address is required on the entry form in this case. Before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.

\* If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, there is no need to apply for a TCN. The CKC will update its records accordingly.

**INCOMPLETE ENTRIES WILL BE RETURNED.** Agents and handlers please note that the **full name and address of owners MUST be filled in** and to whom ID's are to be returned. (Section 13.1.2 Dog Show Rules)

Junior Puppy	A dog 6 months up to 9 months on the day of the show.
Senior Puppy	A dog 9 months and up to 12 months on the day of the show.
12-18 Months	A dog between 12 months and up to 18 months on the day of the show.
Canadian Bred	A dog which was born in Canada.
Bred by Exhibitor	A dog owned and handled by the breeder.
Open Class	A dog 6 months of age or older
Specials Only	Dogs who are Canadian Champions.
Exhibition Only	Dogs 6 months of age and over not in competition.

**Champion & Championship Points** ~ Chapter 1 Section 1 ~ A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of Championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. **NOTE: In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for Championship points.**

### **NON-MEMBER PARTICIPATION FEE**

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number. In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable In Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

**PRIZES:** The BIS, RBIS, BPIS, BBPIS Group 1<sup>st</sup> & PIG Winners in Shows #1, #2, #3 & #4 will receive a floral prize and a rosette from the Oromocto Kennel Club. An award in memory of Dean McMurray will be awarded to each BIS. This award has been donated by the Oromocto Club Members. Rosettes will be awarded to dogs placing Group 2<sup>nd</sup> through 4<sup>th</sup>.

**CATALOGUE:** Catalogues are available on a "pre-order basis" at \$8.00 per copy. Pre-ordered catalogues must be paid for at time of ordering (with entry). Catalogues will be available at the door on a first come first served basis.

#### **RULES & RULE BOOKS**

It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer or participant at any event held under CKC Rules, is not subjected to indignities of any kind. The Show Committee shall promptly report any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of report, indicating that this has occurred.

No person may approach a judge, either directly or otherwise, orally or in writing to favour his/her entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this Rule to the CKC within 14 days of the act (Section 4.1.6 Dog Show rules)

No person shall enter or exhibit a dog under a judge where that judge has owned, conditioned, sold, handled, held under lease or boarded within 6 months prior to the date of the show at which he/she officiates as a Judge. This rule shall apply regardless of whether the judge benefited in any way from any of the aforementioned activities. (Section 4.1.7 dog Show rules).

A copy of the Rules pertaining Dog Shows and/or Obedience Trials is available from the Canadian Kennel Club 1-416-675-5511. It is the responsibility of each exhibitor to know the rules pertaining to these events.

**Note: The precincts of this show ~ the rings and 3 feet surrounding the rings.**

#### **GENERAL RULES**

The Show Superintendent will be in complete charge of these events, which are governed by CKC rules.

All Judging will commence at 9:00 a.m. unless entries warrant an earlier or later start time. Group Judging will commence on completion of Breed Judging within each Group. **PROVIDING TIME ALLOWS**, a break at the end of each group will allow for photographs to be taken. No two groups will be judged at the same time.

"Double Handling" will not be tolerated. The Superintendent reserves the right to request those exhibitors doing so to leave the site.

The Oromocto Kennel Club will use all due care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible in the event of an accident to dogs, exhibitors or spectators  
The Oromocto Kennel Club will not be responsible for any equipment left on the show site.  
"Puppy For Sale" and "Dog For Sale" signs will not be permitted on the site.  
There will be no prong or spike collars permitted at this venue. Abuse of any kind will not be tolerated.  
Dogs not entered in competition or on exhibition are not permitted within the precincts.  
Children, accompanied by an adult, are welcome at our shows. However, please do not allow them to be unsupervised.  
There will be portable washrooms only for show exhibitors.

**LIMITED POWER HOOK-UPS MAY BE AVAILABLE IN THE DESIGNATED GROOMING AREAS FOR EXHIBITORS. PLEASE PLAN ON ALTERNATE SOURCE OF POWER IF YOU WILL BE NEEDING IT FOR SURE. THERE IS NO POWER OR WATER HOOK-UP AVAILABLE TO RVS/CAMPERS WISHING TO PARK FOR THE WEEKEND. THESE UNITS MUST BE SELF SUFFICIENT. IF ANY RV/CAMPER ARE FOUND TO BE PLUGGED INTO AVAILABLE OUTLETS THEY MAY BE PROHIBITED FROM SHOWING AT THIS EVENT IN THE FUTURE.
