3.4.2 Replacement Judge

(b) All those who have entered dogs under the advertised judge (*Mr Denis*) shall be allowed to withdraw at any time prior to judging of that trial. All requests for withdrawal shall be in writing and all entry fees and listing fees will be returned to the owner or the authorized agent of the dog. When possible, the trial-giving club will attempt to notify exhibitors of the judging change at the time the judging schedule is sent out.

3.4.4 A qualifying score earned under a substitute or replacement judge (*Ms Roswell*) will be considered as having been earned under the advertised judge (*Mr Denis*).

6.9 Moving Up

6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.
