AAC ID CARDS: You MUST have a valid Dog ID Number and ID Card from the Agility Association of Canada [AAC] to compete for Qualifying runs and Titles. You can apply online for an ID card at http://aac.ca/en/Dog-ID-Registration. Dog ID cards must be shown at check-in if your dog has not trialed at a L2P event before, or since 2018 with the new jump heights.

Confirmations will be emailed as soon as they are processed and running orders will be emailed after the closing deadline.

SITE

Glade Acres, 2242 Upper Glade Road, Glade, BC.

There is limited shade.

Directions from Highway 3A between Castlegar and Nelson: Turn onto Glade Ferry Road (across from the Esso Station). Continue down Ferry Road to the ferry. Take ferry across Kootenay River. After ferry, turn left at first intersection onto Glade Road. Then turn right onto Morraine Rd, then part way up the hill, turn left onto Upper Glade Rd. Glade Acres (Dan and Glenda Harris) is on the right at 2242 Upper Glade Road).

Crating & Set-Up: The site will be available after 2pm on Friday. Lost or damaged personal property is not the responsibility of Love 2 Play or the Harris'.

AWARDS

AAC qualifying ribbons will be awarded, as will AAC 1st to 4th placement ribbons.

MOVE UPS

Move-ups from prior trials must be reported no later than one week prior to the trial. Please contact the Trial Secretary. We will attempt to also accommodate same day move-ups when possible.

NOTICE TO COMPETITORS

Competitors, through submission of entry, acknowledge that they are knowledgeable of the most current AAC rules and regulations including, but not limited to, the following rules regarding entry:

- **Bitches in season are permitted to** compete in this trial. As per the AAC pilot project ending Dec 31, 2023 bitches in season (BIS) are able to attend this AAC sanctioned trial. Details are at the end of the premium.
- All dogs must be registered with AAC to compete in the agility trial. It is your responsibility to provide the Trial Secretary with your dog's AAC number prior to the closing date or your entry will be rejected.
- **Safety** shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- Obstacles shall be chosen from those described in the most current rules and regulations of the AAC and shall conform to this organization's specifications. All contacts are rubberized; Love 2 Play does not have electronic timing.
- It is expressly understood that competitors alone are responsible for the behaviour of their dogs and/or children. Any competitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behaviour may be asked to leave. NO REFUND of fees will be paid.
- All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when they
 leave the ring after their run. Any dog engaging in aggressive or out of control behavior when leaving the ring
 will be disqualified and/or required to leave the trial site. NO REFUND of fees will be paid.
- Exhibitors must keep crate and exercise areas clean. Please pick up after yourself and your dogs. We need to keep this great venue available for future dog events!
- There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/ injured dogs and then only if the Trial Secretary is notified prior to the trial date and provided with a vet's certificate.
- Trial organizers reserve the right to refuse any entry and if an exhibitor must be asked to leave the show grounds for any reason, they will not be issued a refund.

All competitors are expected to volunteer during the trial.

BITCHES IN SEASON POLICY

As per AAC Rulebook Update v. 8.7 (July 1, 2022), Love2Play is allowing bitches in season (BIS) to attend the trial site and to compete in this AAC sanctioned trial, using the following procedures:

- Handlers are required to notify the trial secretary of a BIS at the trial as soon as it is known
- Handlers of BIS must minimize exposure of their BIS to other dogs and limit their movements on the trial grounds
- The handler of the BIS or the handler of any other dog may withdraw from the trial with a full refund if they choose not to compete because of the BIS
- Competitors will be notified that there will be BIS on site
- A protective mat shall be used at the start line. The handler is responsible for supplying their own mat in good repair and, cleaning it appropriately
- BIS will run as a group at the end of each class
- "BIS" will be noted next to the dog's name on the gate sheet so that other competitors, ring crew and Judges are aware
- BIS will be crated at or in their vehicle, isolated from other crating areas
- BIS must use a designated walking and relief area
- BIS must wear well-fitted protective panties, specifically designed for the purpose of containing seasonal discharges. Panties may only be removed when running, when in the designated relief area, or when crated.
