### CKC Agility Rule changes (in 2014):

- A dog entered in Selected division may not move into Regular division at a later date. Dogs can no longer run two divisions.
- Lateral movement from Regular to Selected divisions.
- PAD –This strategic game involves a point gathering component and a distance element.
- STEEPLECHASE – This fast paced game is designed to test the dog's ability to negotiate a jumpers style course while performing the A frame and weave poles.
- Some Class Standard Course Times have changed in order to provide more time for some jump heights and levels
- A and B levels have been eliminated in both Novice and Excellent levels. The highest level is now called Master Excellent
- Positionless table performance with a continual table count
- Weave poles in all Novice Classes
- One bar jumps can be used at any level
- A frame at 5 feet for dogs jumping 12" or less.

## GENERAL INFORMATION

The Trial Secretary is in full charge of the Trials.

- ❖ No provision will be made for inclement weather.
- ❖ A limited area for indoor crating is available.
- ❖ There is no camping, water or hydro at this location.
- ❖ Food or toys are not permitted in the course area and handlers are not permitted to use whistles or other instruments or devices in the ring or within 10 feet of the course.
- ❖ There will be contact familiarization. A warm up area with one jump will be provided.
- ❖ Handlers in all classes will be able to walk the course, without their dog, prior to the start of the class.
- ❖ It is the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

- ❖ **MESSAGE FROM MCCANN'S RE: THE TURF:** CLEANING OR MAINTAINING OF THE ARTIFICIAL GRASS CAN BE A CHALLENGE. IT CAN NOT BE WASHED OR VACUUMED. ALL DEBRIS THAT FALLS INTO THE TURF MUST BE PAINSTAKINGLY REMOVED BY HAND. THEREFORE, WE REQUEST THAT YOU PLACE EITHER A GRASS MAT OR TARP BENEATH YOUR CRATES, CHAIR AND ALL BELONGINGS. PLEASE ASSIST US BY CLEANING UP YOUR OWN AREA UPON DEPARTURE. YOU ARE RESPONSIBLE FOR LEAVING YOUR AREA AS CLEAN AS POSSIBLE. WHEN LEAVING, PLEASE DO NOT SHAKE YOUR TARP INSIDE THE BUILDING. IF YOU SPILL SOMETHING OR IF YOUR DOG HAS AN ACCIDENT ON THE ARTIFICIAL GRASS, IT WILL NEED TO BE BLOTTED WITH PAPER TOWEL IMMEDIATELY, THEN DOUSED WITH WATER/VINEGAR SOLUTION. WITH YOUR ASSISTANCE WE ANTICIPATE ENJOYING THE SPORTS FIELD FOR MANY YEARS TO COME. ALSO, A REMINDER, PLEASE DO NOT DUMP WATER BOWLS OUT THE FRONT DOOR FOR SOMEONE TO SLIP ON, BESIDE THE BUILDING OR OVER THE FENCE WOULD BE SAFEST.

- ❖ LATE ENTRIES WILL BE ACCEPTED ON THE DAY OF THE TRIAL NOT LATER THAN ONE HOUR PRIOR TO TRIAL. Late entries will be at a fee of \$33.00 per run and will only be accepted by the trial secretary if room permits within the trial/class.

#### EVENT INFORMATION

- ❖ Handlers must be ready at the start line when called or risk forfeiting their run.

#### OBSTACLES

- ❖ Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2014.
- ❖ The A-frame is full size (except as provided in new rules for dog s jumping 12" or less) and 24" weave poles will be used.
- ❖ the tire will be set at 4" lower than the height of the jump (except 4")
- ❖ Electronic timer will be used.

#### ELIGIBILITY

- ❖ To be eligible to compete in these trials, a dog must be 18 mos. of age and registered or be eligible for registration with the CKC, have an ERN or CKC Miscellaneous Certificate, or be a mixed/unrecognized breed with a CKC CCN number.
- ❖ Spayed bitches, debarked dogs, and neutered males are eligible to participate.

## CKC NON-MEMBER PARTICIPATION FEE:

- 1) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee
- 2) In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- 3) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members or American exhibitors.

## EVENT REGISTRATION NUMBER (ERN)

To obtain an ERN simply do the following:

Send a photocopy of the dog's registration certificate reflecting current ownership with a written request for an ERN.

Accounts may be paid with personal or business cheque, money order, Visa or MasterCard. For non-members of the CKC please note that if paying by cheque, the cheque must be certified. Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates.

Provide a full return address. Faxed request will be accepted. Please ensure that your Visa or MasterCard number is legible and that you have included the expiry date and signature. An ERN must be obtained within 30 days of the first day of entering a CKC event. If factors beyond your control prohibit this or present a problem, please send a written request for a 30-day extension. Forward ERN request to:

## ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. SELECTED CLASS — Section 8.4 CKC Jan 1/2010 rule book. The Selected Classes follow the Agility Trials Rules & Regulations. The Courses will be the same as in the regular classes but will have adjusted height & course times (see Section 12.5.8)

### ENTRY INFORMATION:

- ❖ The owner or handler of the dog must sign the Liability Agreement on the back of the entry form. Incomplete entries will be returned.
- ❖ Entries will only be accepted if accompanied by the correct fees.
- ❖ Courier entries will be accepted if no signatures are required.
- ❖ Move-ups will be allowed after the closing date, up to 56 hrs prior to the scheduled start of Trial #53. **Since the Standard and JWW in the two trials each day are running concurrently, there are no move-ups between Trials 53 and 54, and between Trials 55 and 56.**
- ❖ Alterations, substitutions or cancellations of any entry after the closing date is prohibited, except Move Ups.
- ❖ Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- ❖ Judging schedules will be e-mailed as soon as possible after the closing date.
- ❖ Tendering a NSF cheque is considered non-payment of fees and is punishable by disciplinary action. Any NSF cheque will be subject to a \$20.00 service charge.
- ❖ Day-of Entries will be accepted up to one hour prior to the start of the trial by the trial secretary only if there is room in that trial/Class.
