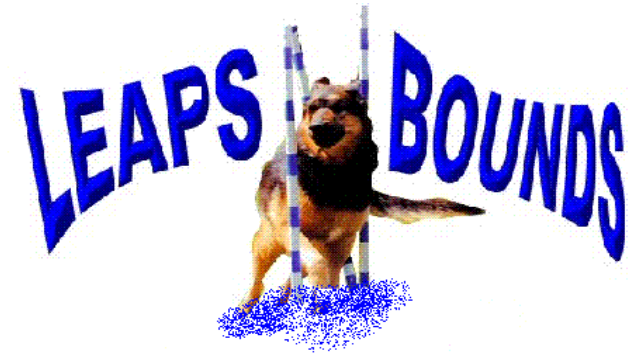
If your dog does not have a completed AAC Measurement card you must have your dog measured before you attempt to check in.
