RULES

A copy of the Rules pertaining to Dog Shows and/or Obedience Trials is available from the Canadian Kennel Club. It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian funds" or "At par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

Dogs competing in Brace, Team, Stud Dog, Brood Bitch Classes must be entered in a Regular Class or for Exhibition Only. Get and Progeny must be entered in a Regular Class.

Bitches in season may not compete and must be withdrawn. Entry and Listing Fee will be refunded provided that written notice is given to the Trial Secretary prior to the start of the Trial.

ENTRY INFORMATION

Dogs must be either registered with the C.K.C. or have an Event Registration Number (ERN). All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an ERN. An ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. An ERN may be obtained by contacting the CKC at (416) 675-5511 or Fax (416) 675-6506. A listing fee is payable with Entry Fees for any dog not having an individual Registration Number at closing date.

PRIZES

Suitable prizes will be offered for Best in Specialty, Best Puppy in Specialty, 2nd, 3rd & 4th in Group, Best of Breed, Best of Opposite Sex, Best Puppy in Breed, Best Brace in Specialty, and Best Team in Specialty, Best Stud Dog & Get, Best Brood Bitch & Progeny, Best Baby Puppy in Specialty

BEST OF BREED, SOFT COATED WHEATEN TERRIER – MARY THOREN TROPHY

Awards of Merit will be offered for every 10 dogs competing in a breed at breed level, at the judge's discretion.

Border Terrier Canada is pleased to offer a prize for each Border Terrier qualifying in the Rally Trial.

JUNIOR HANDLING: Suitable prizes will be awarded for Pee Wee, Junior, Intermediate, Senior, Best Overall and Reserve Overall. Registration for Junior Handling will be from 9 am to 10:30 am. Pre-registration is available by emailing Chantelle at marshall_chantelle@yahoo.ca. Dogs competing in Junior Handling must be entered in regular classes or in Exhibition only.

A fee of \$2.00 for Junior Handling is required at the time of registration.
