Limited overnight camping/trailers at HQ are welcome by reservation... NO HOOK UPS.

- Refunds of tracking entries will only be made if there is an alternate that can take the place of an absentee. Bitches in heat CAN compete in tracking tests. Tracking test entries are limited by CKC rules for maximum a judge can judge in a day.
- Refunds of Rally/field test entry fees will only be made for bitches in heat, with a Veterinarian's certificate.
- The fenced training area and adjoining parking area are considered the trial area. Rally ring size: 50' by 80', grass.
- Dogs are welcome to swim in the west pond , but must be under control and not a disturbance to dogs working in the ring.
- CKC 20-7: It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer, or competitor at a CKC event held under these regulations, is not subject to indignities of any kind. The trial

committee chair shall promptly report to the CKC any infringement of this regulation and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating this has occurred.

Tracking Tests are held in the general area but some driving is required for the different Urban sites. Retriever Field tests will be held nearby at different locations (depending on cover and water levels, etc).

**Sept 21-22**

**2 Retriever WC, WCI, and WCX tests each day. Limited entry.**

**Judging panels**

Saturday morning, 8am: WC-I-X: Allan Mitchell, Brampton, & Gwyneth McClellan, Osgoode, ON.  
Saturday afternoon: (approx 1pm): WC-I-X: Allan Mitchell, Brampton, & Dan Cooke, Kaministiquia, ON.  
Sunbday morning: 8am: WC-I-X: Gwyneth McClellan, Osgoode, ON, & Yvon Touchette, Azilda, ON.  
Sunday afternoon, on conclusion of morning tests: WC-I-X: Dan Cooke, Kaministiquia, and Yvon Touchette, Azilda, ON.

Entries will close when the limit for each test is reached, or on Sept 11.  
Move ups will be accepted each day at lunch time, pending space in afternoon tests.

**Entry fees:**

WC - \$40, WCI: \$45, WCX - \$50.

**\$10 CKC listing fee per entry, required for any dog who does not have a CKC number on the entry form.**

Entry fees are payable to "EPS Training Assoc", and mailed to Ivan Paul, RR 4, Powassan, ON., P0H1Z0.

Rosettes will be awarded to all passing dogs.

• **Sept 28-29.**

• **2 Tracking Tests and 4 rally trials.**

• **All levels with TD/TDX getting preference on the Saturday; UTD/UTDX only on the Sunday.**

**Entries for the Sept Tracking tests, and Rally trials, close Sept 18 unless the rally trials' limit of 5 hours overall judging time is reached first.**

There will be workers draws for each day in the tracking trials.

Draws for entry in the tracking tests will take place at 6pm, Sept 18, at trial HQ.

Owner/handlers will be notified the same evening.

Mixed breed dogs accepted in Rally and Tracking if space permits.

Day of entries accepted for the rally trials if space permits.

If the TD/TDX tracking entries do not fill, and there are available Urban alternates, they will be run on the Saturday.

**Pot luck lunch each day. Please bring your favourite dish in a recyclable/disposable bowl/dish.**

Draws for each day's tracks will take place each morning at HQ, time to be announced once entries have closed.

**Sept 28 - morning**

TD and TDX tests, Judge: Laura McKay, Guelph, ON.

**Sept 28 - afternoon:**

2 Rally trials. Judge: Sheena McKeegan, Chelmsford, ON.  
Outdoors...no cover in case of inclement weather.

**Sept 29 - morning.**

UTD and UTDX tests. Judge: Laura McKay, Guelph, ON.

**Sept 29 - afternoon.**

2 rally trials, Judge: Guy Touchette, Chelmsford, ON.  
Outdoors...no cover in case of inclement weather.

Rally trial judging not to start before 12.30 noon. ...on conclusion of the morning Tracking test.

**LIMIT OF 5 HOURS JUDGING, COMBINED RALLY TRIALS' ENTRY**

**Entry fees:**

\$85 for TD/UTD;

\$125 for TDX/UTDX.

\$30 for Rally per trial.

2nd entry in Rally, same dog, same trial, \$25.

**SPECIAL:** Any dog entered in the Tracking tests, \$25 for first entry, and \$20 for second entry in Rally, same dog, same trial. \$10 CKC listing fee per entry, required for any dog who does not have a CKC number on the entry form.

**Prizes:**

Rosette, prize, and certificate will be awarded to all dogs passing in tracking.  
A prize will be awarded , qualifying score required, to a dog placing first in each Rally class.

Highest combined score, same class, in Rally each day,

Oldest dog earning a qualifying score in Rally each day

Youngest dog earning a qualifying score in rally

New title rosettes for dogs completing any Rally title.
