- 3. Pre-entries may be mailed, hand-delivered to the Event Secretary.
- 4. **Mailed Entries** must include the entire form and be signed. Mailed entries received without fees shall not be accepted.

PAYMENT

- 1. Payment may be made by cash, cheques, money order, Interac E Transfer. Contact the Show Secretary for E Transfer Number
- 2. No entry will be accepted without payment.
- 3. Make cheques and money orders payable to the Grand River Kennel Club.
- 4. Post-dated cheques and returned cheques do not constitute valid entry fees. This club will add returned cheque fee to the amount of each returned cheques or money order.
- 5. **Foreign Exhibitors:** Please be aware that fees are due and payable in Canadian dollars, discounted cheques will not be accepted.
