CKC NON-MEMBER PARTICIPATION FEE

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line). The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

JUDGING PROCEDURE

Judging of the All-Breed Sweepstakes will commence at approximately 12:00 Noon. However, if necessary a later starting time may be announced for any one or more of the rings. (See judging program for further details). Breed judging will start again at the scheduled time. Within each group, dogs will be judged SEXES COMBINED. Baby Puppies are not eligible.

RULES and AWARDS

All dogs entered on the day shall be eligible to compete, regardless of place of birth. All dogs entered in the sweepstakes must also be entered in a regular class at the All Breed Show, on the day of the Sweepstakes. Money received as entry fee for the sweepstakes will be pooled and divided as follows:

Best in Sweeps.....	5% of entry fees received & Prize
1st in each Group	25% of entry fees received for that class
2nd in each Group.....	20% of entry fees received for that class
3rd in each Group.....	15% of entry fees received for that class
4th in each Group.....	10% of entry fees received for that class

The remaining 25% of all entry fees will be retained to cover administration cost. Rosettes will be awarded for Best in each Group and Best in Sweepstakes. Flat ribbons will be awarded for first to fourth place in each class. A prize from the TIKO Club for Best in Sweepstakes will be awarded. If a dog is required for judging in one of the regular classes, judging of the sweepstakes in that group will be suspended until judging of the regular class has been completed.

OWNER / HANDLER COMPETITION (OH)
FRIDAY, AUGUST 18, 2017

Baby Puppies are not eligible for this competition

Owner / Handler Box must be checked on entry form

(A * will indicate each **OH** dog listed in both the catalogue and on the Ring Steward sheets.)

1. This is open to all **non-professional** owner / handlers. Professional defined as anyone who has been hired to assist a handler or paid to handle or received remuneration or a licensed / permit judge. Dogs must be **OH** throughout the competition.
2. Judging of **OH** will take place after Breed Judging Competition unless automatic.
3. **OH** Best of Breed will be selected from the dogs eligible to compete for **BB**.
4. If the Best of Breed dog is **BOH** it will automatically be the **OH BB**.
5. If ineligible, then the next highest **BOH** placement will compete against the eligible dogs of the opposite sex.
6. Should none of the **BB** competitive dogs be **OH** then any **OH** dogs (not directly or indirectly defeated in the classes by an **OH** dog) will be invited back.
7. The **OH BB** dogs will compete for **Best OH** in Group immediately after Regular Group Judging.
8. Should the Regular Group 1st dog be **OH** then it will be automatically **OH in Group**.
9. If no **OH** places in the Group (1-4) then all **BB OH** dogs will be called into the ring for **OH Group Judging**.
10. If the **BIS** dog is **OH**, then it will automatically be **OH BIS**
11. A flat ribbon will be offered for Best **OH** in Breed, a Rosette for Best **OH** in Group, a prize for **BOH** in Group (Saturday & Sunday) and a Rosette and prize for Best **OH** in Show.

***** If you are an OWNER / HANDLER**

**make sure that you check off the box on the entry form
in order to be eligible to compete.**

CLASSES

- Baby Puppy -A dog 3 months of age and under 6 months on the day of the show
- Junior Puppy -A dog 6 months of age and under 9 months on the day of the show
- Senior Puppy -A dog 9 months of age and under 12 months on the day of the show.
- 12 - 18 Months -A dog 12 months of age and under 18 months on the day of the show
- Canadian Bred -A dog which is born in Canada.
- Bred by Exhibitor -The handler must be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog further for awards.

- Open Class -For all dogs.
- Veterans -A dog 7 years and over on the day of the show. May be spayed or neutered.
- Specials Only -Dogs which have a recorded CKC registration or Event Registration Number (ERN) and have attained the required points for Championship Status. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy in Breed if eligible.

- Brace -Two dogs of the same breed (not necessarily of the same sex). Should be judged as an identical pair - same colour, size, gait & stride. When viewed from the side they should appear as one dog and its shadow. Handled by 1 person on 1 lead.

- Altered -Dogs which have been spayed or neutered.

1. Building will open at 7:00 am Friday, Saturday and Sunday and close at midnight Friday and Saturday. Exhibitors must vacate the building 1 hour after Best in Show on Sunday.
2. In Transit area available.
3. To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept entries reaching the Show Secretary after the official closing date as published in this premium list.
4. **No entry will be accepted unless all particulars called for on the entry form are shown thereon. INCOMPLETE ENTRIES WILL BE RETURNED. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY ENTRY FEES.**
5. TELEPHONE & TELEGRAPH ENTRIES CANNOT BE ACCEPTED.
6. DIANA EDWARDS SHOW SERVICES, reserves the right to refuse any entry, subject to C.K.C.Dog Show Rules.
7. Acknowledgement of Entry and judging schedule will be mailed as soon as possible after entries close.
8. The person accompanying the dog must show Acknowledgement of Entry before the dog is allowed in the show and, unless a dog is entered officially, it will not be allowed in the show precincts, with the exception of dogs to be kept in the "In Transit" area. Show Precincts are the whole Memorial Centre building proper plus anything within ten feet of the outdoor rings.
9. It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is scheduled for judging.
10. D.E.S.S. and the T.I.K.O. Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or misfortune, to either dogs, exhibitors or patrons.
11. Conflicts between Dog Show Rules and New Breed Standards. The Board of Directors of the CKC has ruled that, where there is a conflict between the Breed Standards and the Dog Show Rules the Dog Show Rules will take precedence.
12. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. Changes or cancellation of any entry after closing date is prohibited.
13. If, because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.
14. To avoid noise and confusion, there will be no individual dogs called to the ring by loud-speaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
15. We will have someone clean up during the show times, but remember they cannot be everywhere at once. Your co-operation in cleaning up after your dog is much appreciated.
16. By virtue of entering these shows -
I (we) agree to hold the Thousand Islands Kennel and Obedience Club (TIKO), and the owners of the premises on which this event takes place harmless from any claim for loss or injury which may be alleged to have been caused, directly or indirectly, to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the afore mentioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, caused or alleged to be caused by negligence of the aforementioned parties responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by the reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event howsoever such injuries, death or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their agents or other persons.

PLEASE NOTE

It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. 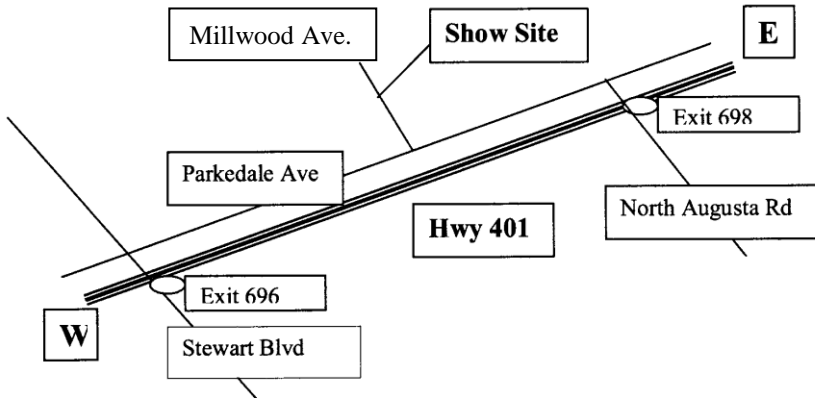
