If you do not have a CARO Reg. # card for your dog, please submit the appropriate CARO application form which can be found at http://www.canadianrallyo.ca/Files_Word/F-02-Individual%20Dog%20Registration%20Form%202010.doc Please note that it takes several weeks to get a CARO Reg. #. A valid CARO Dog Reg. # card must be presented at the trial check-in; otherwise the dog will not be permitted to compete at this trial.

Awards

- Qualifying Ribbons for CARO qualifiers.

Facilities:

- The trial will be held at The Playground, a fully matted indoor facility
- This is a one-ring event.
- A crating area is available inside the building
- Competitors are responsible for their own crating, seating, food & water.
- No Canteen on premises, competitors are responsible for their own meals.

Dogs:

- All dogs must be kept in a crate or on leash when not in the ring (please no x-pens)
- Handlers are responsible to keep their dogs quiet at all times.
- Handlers are responsible to clean up after their dogs. Clean up baggies will be provided.
- Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. There will be no refund of fees in such instances.
- Any handler displaying inhumane or aggressive treatment of any dog, or other participants, judges or volunteers, be it physically or verbally, while on site, will be asked to leave the trial grounds. There will be no refund of fees in such instances and all legs earned will be null and void.

Move Ups: Will be permitted providing the Trial Secretary is informed in writing at least one (1) week prior to this event.
