Masks MUST be worn at ALL times in the Red Barn. When running your dog, you may remove your mask.

We are allowing crating space in the Red Barn. Please note that dogs in the area marked as non reactive must be able to sit quietly in their crates. If your dog is not able to do this (even while you are volunteering in the ring) please crate in the GENERAL crating area. You are still welcome to crate from your car but we are not calling out names in parking lot. Please refer to the map included as an attachment to this email.

You will get course maps at the registration desk where you will be checking in and selecting your volunteering positions (you will get two stickers with your name on it and you can stick it on two spots to help). Course maps for Standard Excellent and intermediate will be handed out in the am, the rest after the novice warm up run. Barb, the volunteer coordinator will be there to assist you. Your entry was dependant on your volunteering for at least 2 positions during the trial, without you we would be unable to run the trial.

Please note we will not have a leash runner. Please either put your leash in your pocket or bring a second leash and hang it on the wall at finish area. All dogs must enter and leave the ring on leash.

In 2010 the Board of Directors of the CKC passed a motion with respect to a Non-Member Tracking Fee for Canadians that participate in CKC events and are not CKC members. At the December 2010 Board of Directors meeting, the Tracking fee motion was deleted and replaced with the following motion. Non-Member Participation Fee a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. This fee will match the ERN fee. b) In order to protect the awards/titles earned, the non-member will have a choice either, to become a CKC member or to pay the non-member Participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. c) The Premium List must carry a note stating that these fees apply only to dogs wholly owned by non- CKC members and are not applicable to CKC members. The Non-Member Participation Fee is effective January 1, 2011. Cost is \$63.90 + HST
