INFORMATION FOR EXHIBITORS

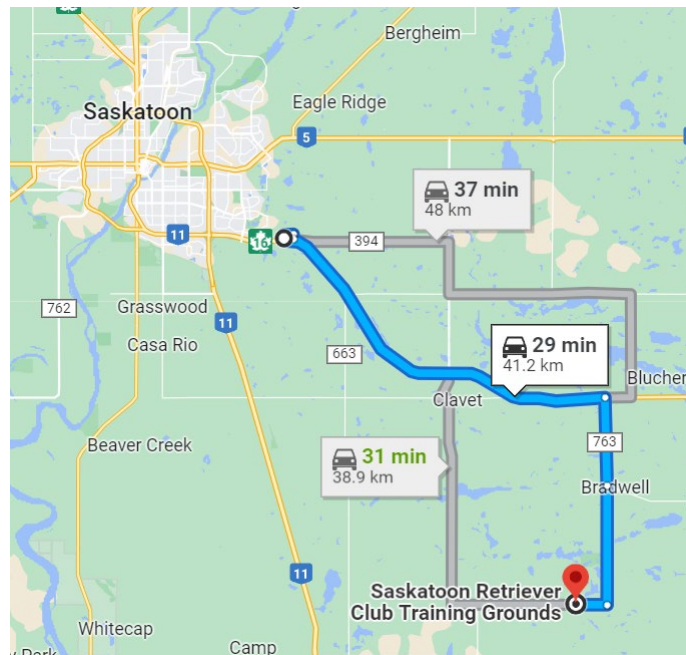
1. Dogs without an individual registration number (RN) or event registration number (ERN) and entered with a Temporary Competition Number (TCN) are required to pay a \$10.50 listing fee (GST included)
2. A non-member participation fee, for awards and titles, will be charged to Canadian non-members of CKC. Exhibitors have the choice to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in cancellation of awards and titles
3. Female dogs in season are not eligible for entry
4. Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least 24hrs prior to the starting time of test. 'No shows' or scratches within 24hrs of event start time will forfeit full entry. Bitches in heat will be provided a full refund as they are not to be on test grounds at any WC event
5. If a dog is not present within 15min of being called to the line it may be disqualified
6. CKC Rosettes will be awarded to all qualifying dogs in each event
7. In working certificate test, gunners, throwers or handlers shall not wear distinctively white or light clothing at any time but handlers may wear handling jackets for the blinds in the WCX
8. There shall be no training of dogs on the test grounds starting 24 hours prior to event and ending upon event completion

NOTICE TO EXHIBITORS

1. It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
2. The Saskatoon Retriever Club will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise. Furthermore, the Saskatoon Retriever Club will assume no liability in the event of an accident or other misfortune to event participants, bystanders, club members, workers or other individuals using the property for any purpose
3. **Release and indemnification of Landowners and the Saskatoon Retriever Club**
By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all his heirs, executors and assigns.

2. Turn south on HWY763 and continue for 13km
3. Turn west on unnamed road (see Saskatoon Retriever Club sign) and continue for 2km
