### FEES

FD, FDA, FDX/FDXCh - \$60 /day;  
Day of entry: \$70  
FDJ: \$50/day; Day of entry \$60  
CKC Listing Fee: \$9.60 (includes HST)

**Note:** A listing fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form.

### ENTRIES

Dogs must be at least 6 months of age to be entered. Entries are limited to the number of dogs able to run during daylight hours and may be limited for brace categories. Entries close midnight Wed. May 10, 2017.

Day-of-entries may be limited by number of entries received prior to the closing, availability of birds and/or, availability of a bye-dog or braces for FDA, FDX & FDXCH. Day-of-entries must be received no later than 30 minutes prior to the start of each class. It's the owner/agent's responsibility to arrive early for day-of entries and there is no guarantee entry will be accepted. If accepted, day-of-entries constitute a legal commitment to pay and cannot be withdrawn or refunded.

Entrants are responsible for confirming receipt of their entries. Cancellations must be made in writing and must

be received before the closing date, in which case refunds will be provided in full. No refunds after closing and for bitches which come into season after close of entries. If your dog has twice qualified with any of our Judges, notify the Test Secretary before the drawing time.

### NON-PAYMENT OR DISHONoured PAYMENT

Payment must be made in full and accompany the entry form or be provided by cheque or cash prior to the start of the test for which the dog has been entered. No payment = no run. The VSO reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Tendering of a dishonored cheque or declined credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Postdated cheques are not acceptable tender.

## INFORMATION AND RULES

**Start time:** 8:00 AM

**Running Order:** FDX / FDXCh followed by FDA, FD and FDJ.

**Course and Game:** FDJ, FD, and FDA will be a single course with bird field. FDX and FDXCh will be a single course.

FDX/CH, FDX and FDA dogs will be run in braces or individually where applicable with a bye dog for backing.

**Birds:** Chukars will be used in all categories. Dead Chukars will be used in the FDX/FDXCh water retrieve.

**Gunning:** Done by official gunners only. All handlers must carry a starter pistol.

**Safety Gear:** All entrants, judges, gunners, volunteers and spectators who enter or are physically present on the test course, must wear blaze orange clothing and blaze orange head gear in any test where shotguns are used. (Clause 11.3 of CKC *Field Dog Test Rules and Regulations for Pointing Dogs*.)

**Indemnity & Waiver:** All participants are required to sign the attached VSO waiver on page 5 either in advance of or at the test. Any spectator wishing to accompany and view a running dog in the test course must also sign a waiver and wear safety gear as outlined above.

**Immunization:** All dogs must have current immunization status before being entered.

**Other:** If a dog is not present at its starting point within 5 minutes after it is called for by the judges, it may be disqualified. No training or running of dogs on the grounds before and during the tests.

**Bitches in season:** are not permitted on the grounds.

**Meals and Refreshments:** Morning coffee and lunch will be available both days for a nominal fee to entrants. Judges and volunteers will be fed first.

## DRAWING & RUNNING ORDER

**Draw:** Running order draw will take place at the home of Test Secretary in Moffat ON, 905-691-8706 on Thursday May 11 at 12:00 Noon. Drawing will be random; specific times cannot be guaranteed.
