In payment of entry fees, the tendering of NSF cheques shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$30.00 will be added to the amount of any returned cheque. Telephone entries are not accepted by the Trial Secretary. Incomplete entries, entries received without fees, or entries received after the advertised closing date will not be accepted. There will be no refund on overpayments or duplicate entries. Please mail entries early to ensure that they are received before the closing date.

**Attention Foreign Exhibitors!**

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

**Non-Member Participation Fee:**

An annual non-member participation fee for awards and titles will be charge to a Canadian non-member of the CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

**Attention Foreign Exhibitors:** ERN numbers must be applied for within 30 days of the first day of entering a CKC event. A CKC ERN registration form can be downloaded from the CKC website: <http://www.ckc.ca>

**Section 18.1 of the CKC Herding Rules states:** The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC.

**Section 15.7 of the CKC Herding Rules states:** It shall be the duty and obligation of the trial-giving club to see that a judge, club officer, ring steward volunteer or competitor at a herding trial held under these regulations, is not subject to indignities of any kind. The Herding Trials Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
