#### Day of Trial Entries will be allowed! Move-ups are permitted.

Entries must be in the hands of the Trial Secretary at least an hour before the start of the General Briefing for each trial. Please provide Move-up Forms as soon as possible. These are available online at the CKC web site or from the Trial Secretary on site

#### **Judging Counts and Schedule**

Judging Counts are included. However, **the final order is pending CKC approval** and may be adjusted by them, or by our judges. Counts could also be affected by Day of Trial Entries or move-ups.

### Saturday June 10, 2023 Trials

• General briefing to begin at **9.00 a.m**. **Trial 1** briefing to follow. At the completion of **Trial 1**, a briefing for **Trial 2** will be held.

#### Sunday June 11, 2023 Trials

• General briefing to begin **no earlier** than **1.00 p.m**. **Trial 3** briefing to follow. At the completion of **Trial 3**, a briefing for **Trial 4** will be held.

Please be at the trial site at least 30 minutes before the handler's meeting so that we can begin on time. We have a very full schedule for these trials so please be ready when it is your turn to run.

Move ups will be allowed between trials. See Trial Secretary as soon as possible to complete a Move Up Form.

## **Facility**

Our host facility is a working farm. Please keep your dogs on leash at all times and stay away from animals in pasture and dogs kennelled at the house. We will have water and toilet facilities on site, please bring shade for yourself and your dogs. This is Alberta, so come prepared for ALL weather.
