## ELIGIBILITY

Only purebred Afghan hounds, Basenji, Borzoi, Greyhounds, Ibizan hounds, Irish Wolfhounds, Pharaoh Hounds, Salukis, Scottish Deerhounds, Whippets and any breed in the miscellaneous group recognized as a sighthound by the CKC. All hounds must be one year of age or older on the day of the trial. Does not registered with the CKC with a regular registration number, Performance Event Number or an Event Registration Number must pay a listing fee which is paid for each trial entered. Altered and neuter hounds may compete. **DOGS PRESENTLY DISQUALIFIED UNDER ASFA, CSFA, AKC OR CKC RULES ARE NOT ELIGIBLE. HOUNDS MUST PRE-QUALIFY BEFORE ENTERING THEIR FIRST TRIAL IN CANADA. IF APPLICABLE, PLEASE PROVIDE PROPER CERTIFICATION WITH YOUR ENTRY.**

## CHAMPIONSHIP POINTS

Championship points are awarded to regular stakes only on the following basis:

1st Place	4 x number of hounds competing in stake with a max of 40 points
2nd Place	3 x number of hounds competing in stake with a max of 30 points
3rd Place	2 x number of hounds competing in stake with a max of 20 points
4th Place	1 x number of hounds competing in stake with a max of 10 points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been excused in the preliminary run, that hound shall not count as having been in competition. Exhibitors please note, as per rule 9.6.1(b) of the CKC Lure Field Trial Rules and Regulations, a dog must "Attain 1 first or 2 second placements by defeating dogs in head to head."

## OFFICIAL STAKES

**OPEN** – For all hounds, including Field Champions

## UNOFFICIAL STAKES

**BEST IN FIELD** – Open to all Best of Breed Winners

**SINGLES** – Open to any hound. Each hound will be run individually twice and scored.

**PUPPY** – Open to puppies 6-18 months. Puppies will be run once individually and scored.

**VETERAN** – Open to hounds over 7 years. Veterans will be run once individually and scored.

## ENTRY FEES

<b>\$15.00</b>	1st hound per trial
<b>\$10.00</b>	2nd and subsequent hound per trial (same household)
<b>\$20.00</b>	Post-entry fee (post entries close 1/2 hour prior to roll call)
<b>\$10.00</b>	Singles Stakes
<b>\$ 5.00</b>	Puppy and Veteran Stakes
<b>\$ 8.72</b>	CKC listing fee for all non-CKC-registered hounds (includes taxes)

*Make cheques payable to the Saluki Club of Canada. Any overpayment of entries fees is considered a trophy donation. (A \$25 fee will be levied for a returned cheque.)*

## TROPHIES AND AWARDS

Rosettes/ribbons will be awarded for BIF and BOB, and for 1st through NBQ. Trophies will be awarded to all BOB winners and BIF.

## U.S. EXHIBITORS

- Please purchase bank drafts or money order payable in Canadian funds. We will accept personal cheques; however, they must be payable for the full amount of the entry. Discounted cheques or those marked “payable in Canadian funds” will not be accepted.
- Foreign-born and foreign-owned dogs may compete with an Event Registration Number (ERN). This must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Please visit the CKC web site for more information ([www.ckc.ca](http://www.ckc.ca)).
- NOTE: A CKC Listing Fee of \$8.72 per dog is payable for each dog that does NOT have a CKC Registration Number or ERN. This \$8.72 is in addition to the regular class entry fee.

## CKC NON-MEMBER PARTICIPATION FEE POLICY

*Effective January 1, 2012:*

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$58.50 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

## FIELD AND EQUIPMENT

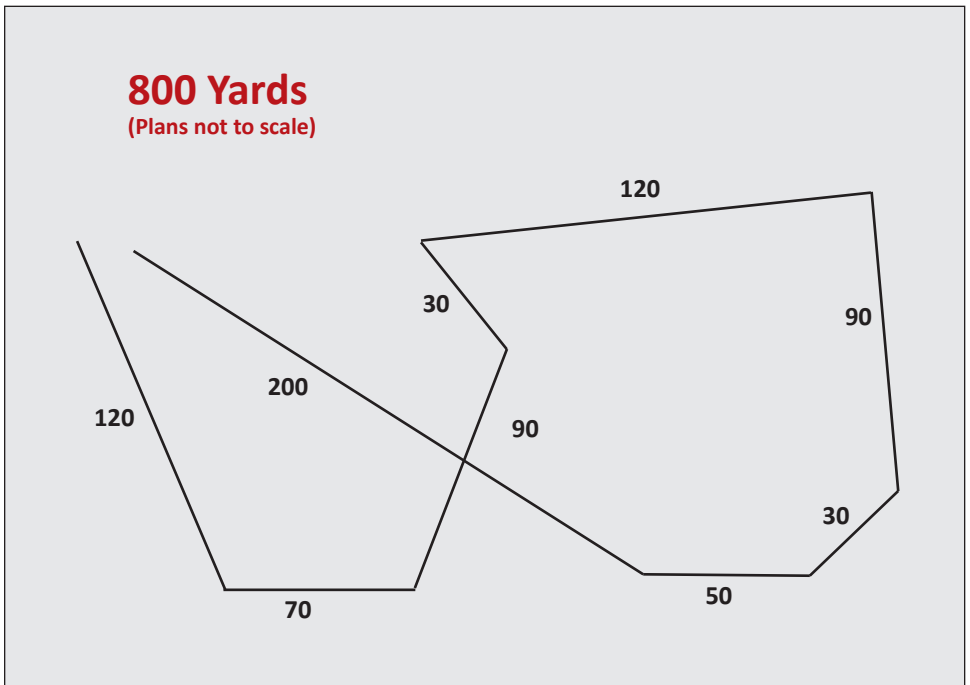
The field is a rough level-grassed area. A continuous loop machine with white plastic streamers will be used. Back up equipment will be on site.

## CONDITIONS

- Stakes will be split if any breed has an entry of more than 24 dogs at the time of the draw.
- All dogs will run twice unless excused, dismissed or disqualified.
- Bitches in season or lame hounds will be excused, and entry will be refunded if notice is given prior to roll call.
- Hounds not present at roll call will be scratched and entry fees will NOT be refunded.
- Handlers must use a slip lead when releasing their hound. All hounds will be slipped from a standing start.
- Muzzles may be worn at the owner's discretion. Leg wrappings must be a neutral colour to comply with CKC rules.
- There will be a \$5 fine for dogs found loose on the coursing field after roll call and before completing Best in Field.
- There will be a \$20 fine for anyone caught not cleaning up after their hound.
- Bring your own water, and shade.

## COURSE PLANS

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Course will be reversed for finals and again for run-offs and BOB. BIF will be as per the judge's request. ***The course may be changed to suit field conditions.***

## **HOUND CERTIFICATION**

A hound must be tested with another dog, of the same breed or a breed with a similar running style (preferably not a kennelmate), and certified running clean by a licensed judge. Hounds must be a minimum of 11 months old prior to being certified, and must run a course of at least 600 yards (548.4m) in order to be certified. Please complete the bottom half of this form and attach it to the entry form for the hound's first entry in a trial. (See Section 7.1.1)
