CONFIRMATION: will be emailed, or mailed to you if you don't provide an email address. If you do not receive a confirmation by 1 week prior to the Match date, or if there are errors, please notify the Match Secretary as soon as possible. This will help avoid delays on the day of the Match.

MATCH SITE: This Match will be held outdoors on grass. Rain or Shine.

CRATING & SET-UP: There will be plenty of space ring side for set up of shade tents etc.

SCHEDULE: Equipment Familiarization: Contact equipment only. Saturday 7:00 a.m. to 7:30 a.m.

Walk thru: 7:50 a.m.

First Dog On The Line: Saturday 8 a.m.

PRIZES AND AWARDS: Flat ribbons will be awarded for 1st through 4th Place.

MATCH RESULTS: The Match results will be posted onsite after completion of your run. We will also be posting final results on the Paws Squad website, www.pawssquad.ca, within few days of the completion of the Match.

This event is open to all dogs being at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, or any dogs showing signs of aggression.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children.

All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.

Exhibitors must keep crating and exercise areas clean. Please pick up after yourself and your dogs. We need to keep this great venue available to us and other dog clubs!

Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees paid will be made.

If an exhibitor must be asked to leave the show grounds for any reason, they will not be issued a refund.

There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/ injured dogs if we are provided with a vet's certificate.
