

## **ENTRY AGREEMENT**

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Belgian Shepherd Dog Club of Canada, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

## **CLASSIFICATION**

**Rally Novice A:** Dogs entered in this class may not have won a CKC Rally Novice title or any CKC Novice Obedience title.

**Rally Novice B:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned.

*No dog may be entered in Rally Novice A and Rally Novice B at any one trial.*

**Rally Advanced A:** For dogs that have won the Rally Novice title but have not won the Rally Advanced title or any CKC Novice Obedience title.

**Rally Advanced B:** For dogs that have won the Rally Novice title.

*No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.*

**Rally Excellent A:** For dogs that have won the Rally Advanced title but have not won the Rally Excellent title or any CKC Novice Obedience title.

**Rally Excellent B:** For dogs that have won the Rally Advanced title.

*No dog may be entered in the Rally Excellent A and Rally Excellent B class at the same show.*

**EXHIBITORS PLEASE NOTE:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Rule books are \$6.00 and can be obtained by contacting the Canadian Kennel Club as above.
