From North Island: Drive south along the Island Hwy, past the Nanaimo (Cassidy) Airport. Turn **left** onto Cedar Rd. **


** Follow Cedar for approx 1.5 km, turn **left** onto Adshead Rd. (same road as the Herb Farm).


COURSE PLANS

OPEN STAKE: For all hounds including Field Champions.

VETERANS STAKE: Hounds designated as veterans on the entry form and entered in the Open Stake will be eligible for an additional prize.

OTHER STAKES

SINGLES STAKE: Open to all sight hounds over the age of 1 year not entered in the trial. Will run individually, twice, after the official runs. Runs will be judged but no points will be awarded. Ties will be decided by a coin toss. Limited to 10 hounds.

PUPPY FUN RUN Saturday: For puppies whose age on the day of the trial is six months, but less than 18 months and who are not entered in the trial. Puppies will run once individually on a shortened course and be scored. Placements of first through NBQ may be awarded but will not count for points. This stake may be divided by age. OLD TIMERS FUN RUN Sunday: For any hound seven years of age or older the day of the
