## General Information

1. Location of these trials is the Superdog Spectrum, #7, 510 – 77<sup>th</sup> Avenue SE, Calgary, AB. Parking is available on the North and west side of the building. The entrance for the show will be on the North side of the building as well. Please respect the no parking signs of other businesses next to the venue.
2. The show building will be open one hour prior (7:30 am) to commencement of judging. **PLEASE NOTE THE DIFFERENT START TIMES. Judging for Ring #2 will start at 8:30 am. Judging for Ring #1 will start at 9:00 am.** If you attend the match on November 21<sup>st</sup>, you will be able to leave your equipment in the building overnight.
3. ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES. If not competing, the dog must wear a collar and be on a leash of a maximum length of six (6) feet or be appropriately confined in the benching area.
4. Benching will be located in the day care area in the back. Signs will be posted. As benching space may be limited, only dogs entered in the show are to be benched here. There will be NO benching at ringside.
5. **Dog Potty Areas:** Please potty dogs in the designated areas ONLY. Signs will be posted. PICKING UP after your dog is not an option, it is a MUST. Persons caught not picking up after their dogs will be excused from the trial.
6. EXHIBITORS PLEASE NOTE: CKC Obedience Trial Rules and Regulations (Chapter 3, Section 3.6.1) "A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out."
7. Exhibitors must abide by errors made in entering their dogs, regardless of how, or by whom, the entry was made.
8. The Show Precincts are defined as "SUPERDOG SPECTRUM".
9. All empty rings are to be kept free of dogs.
10. Cal K-9 Obedience Club of Calgary, its members and volunteers will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
11. The Trial Superintendent has the authority to expel any dogs deemed to be a danger to other dogs or people. There will be no refund for dogs that are expelled.
12. **Indoor Shoes: The Superdog Spectrum has asked us to remind everyone entered in the trial, to bring indoor shoes, as it is most likely the weather will be wet.**
13. A "HOT LUNCH" will be provided to all exhibitors that have prepaid.
