### **PARKING INFORMATION AND MORE**

Please use the parking lot in front of the building.  
No special area will be designated for reactive dogs.

Dogs are to be crated in your vehicle, please bring sufficient shade, water and everything you need to ensure you and your dog are comfortable during your time at the trial.

This is a sport for all dogs, please be mindful of others whose dogs prefer not to interact with other dogs. There will be no indoor crating. Dogs must be contained within handlers' vehicles. Handlers may sit outside next to their vehicles but dogs must be crated outside or contained within the vehicle attached. No dogs in x-pens outside of vehicles. There will be no loose dogs or dogs playing in the parking lot. Dogs are to be on leash at all times and they should remain crated unless out to be pottied or getting ready to go into a search area. If your dog is reactive, please put a red bandana on your pup so that others may easily recognize your needs. ANYONE DISOBEYING THESE RULES WILL BE EXCUSED AND TOLD TO LEAVE WITH NO REFUND.

Will be closed during Master and Excellent Interior searches. We will have them open first thing and during Exterior and Container searches for Master and Excellent. They will be available at all times during Instinct, Novice and Open levels.
