## Judge Biographies



### **John Bryson**

My involvement with purebred dogs began in the late 1970's, when I met my wife of over 40 years, 2 Great Danes were part of the deal. We bred and exhibited Great Danes successfully, owning and breeding Best in Show winners until the mid 90's, when English Foxhounds started to take over the kennel.

Since then, we have bred and owned Best in Show, Royal Group winning & Record-breaking English Foxhounds & Harriers. We have bred or owned over 47 champions in these breeds. In recent years hounds from our kennel Foxhunt have been exported to the USA, Europe and New Zealand.

My three daughters also breed and exhibit dogs and through them I have had a direct involvement in Beagles, Boxers, Shar Pei, Siberian Huskies, Afghan Hounds, Rhodesian Ridgebacks and more recently Dobermanns. All of those breeds have enjoyed considerable success.

I have been involved with club Management for many of the years I have been involved in conformation showing and I am President of Medowie ABKC, Vice President of Liverpool ABKC, Secretary of Bay City ABKC, as well as Show Secretary for many other clubs.

I am privileged to be a Councillor at the Royal Agricultural Society of NSW where my main role currently is Chairman of Domestic Animals, a role which enables me the great honour of overseeing the organisation and successful execution of one of Australia's largest and most prestigious shows The Sydney Royal Dog Show.

My Judging career commenced in 1989 and since then I have been lucky enough to have judged in all states of Australia, overseas in Europe, Asia, and extensively in New Zealand.

For the last 20 years, I have been involved in publishing. Our company Top Dog Media produces canine publications including Dog News Australia of which I am Editor-in-chief. Over two decades it has enabled me to see dogs in depth from Australia, Asia and in fact the world.

As part of my work with Top Dog Media I wrote the bestselling book The Concise Australian Dog Judges Guide, which has now had three editions and been eagerly sought after by judges all over the world.

I look forward to expanding my horizons and judging some wonderful dogs in your country.



### **Kimberly Anne Meredith**

Kimberly has been continuously involved in the sport of purebred dogs since 1972. A breeder-exhibitor of Alaskan Malamutes, she has bred over 60 champions, including multiple all breed Best In Show winners as well as multiple National Specialty winners in a limited breeding program. She has also owned, shown and bred Doberman Pinschers for the past 25 plus years. In addition to exhibiting Alaskan Malamutes and Dobermans, she has owned and exhibited Akitas, Bernese Mtn. Dogs, Lhasa Apsos, Clumber Spaniel, Bassett Hound and Whippets. She is a proud owner of a new French Bulldog Champion that finished his championship in 4 shows at the US National specialty and has completely stolen her heart.

Kimberly judges Best In Show, Jr. Showmanship, the Working, Sporting, Herding, Hound, Non Sporting and Toy groups. She has been honored to judge at many of the countries top shows, including Westminster Kennel Club nine times, the televised AKC National Championship Show and the televised National Dog Show.

She has judged the Alaskan Malamute Club of America, the Akita Club of America (3 times), the Golden Retriever Club of America, the Portuguese Water Dog Club America, the Siberian Husky Club of America, the Border Collie Society of America, the Newfoundland Club of America, the Leonberger Club of America, the Bernese Mtn Dog Club of America, The Bullmastiff Club of America, the Clumber Spaniel Club of America, The Cirneco dell Etna Club of America, the Dog De Bordeaux COA and the Leonberger national specialties. She has judged abroad in France, Italy, Spain, Holland, Belgium, Finland, New Zealand, Germany, Australia, Japan, Denmark, China, and Korea.

She is honored to announce the Westminster Kennel Club televised day time commentary for Fox Sports.

In addition to judging and showing her dogs; she enjoys outdoor sports, collecting and restoring antiques and gardening (aka: slaving in her 2-1/2 Acres of landscaping)



### **Raymond Yurick**

I have a lifelong connection with purebred dogs and Dog Shows, having grown up in this world. My family specialized in breeding Great Pyrenees, and as a junior handler, I had the privilege of showing mainly Afghans and Whippets. My passion for hounds ignited at a young age, and it all started when I got my first personal dog, an Afghan, four decades ago.

After completing high school, I decided to follow my heart and pursue a career in showing dogs. I began by working as an assistant for highly respected Top Canadian Handlers, who provided me with valuable guidance and training. Throughout my journey, I've had the joy of owning and co-breeding a diverse range of wonderful dogs from various groups, including Afghans, Pointers, West Highland Whites, Australian Terriers, Wire Fox Terriers, Bichons, Toy and Miniature Poodles, and Bouviers. However, my true passion for the past three decades has been with Whippets.

I take great pride in my involvement with the Whippet breed, under the Brushwood and Bretica prefix. I've been fortunate enough to breed and co-breed some exceptional Whippets, with achievements such as AWC and NWCC National Specialty winners, Canadian and American BIS winners, numerous champions, and many cherished and healthy pets.

Outside of the dog world, I have several hobbies and interests, including painting, sculpture, and writing. I am especially proud of co-founding and publishing the Canadian Dog Digest alongside my sister Yvonne Yurick Norton.

In addition to my handling career, I've also spent 11 years as a judge, evaluating numerous group and individual breed specialties in Canada, USA, and Australia. It's an absolute honour to be invited back to judge for Evelyn Kenny KC, A club I spent so much time involved with when I lived in Calgary. I'm eagerly looking forward to an amazing weekend with remarkable dogs and passionate people.



### **Jo Ann Pavey**

I have owned, bred, trained and shown Shetland Sheepdogs for over 50 years. Our dogs have been very successful in all rings on both sides of the border. I am a lifetime student of all purebred dogs and to that end I now judge all of the Sporting, Hound, Working, Terrier, Toy and Herding Groups. I am currently on permit for the Non Sporting Group. I have judged Group Specialty Shows for Herding and Toys, as well as Specialty Shows for Collies, Belgian Shepherd Dogs, Cavalier King Charles Spaniels, Pembroke Welsh Corgis, Finnish Lapphunds (National), Gordon Setters and Australian Shepherds (ASCA). I have served as a director of the Samoyed Association of Canada, President of the Northwestern Ontario Working Dog Association and Director of the Samoyed Club of Ontario. I am currently a member of CDJA and serve on the Judges Education Committee for the Samoyed Club of America. I have more recently began to instruct beginner and advanced Handling seminars at our US Nationals. I was born and live in Thunder Bay, Ontario. In my professional work life, I am a Master Electrician and owner of a family business. I took the leap into meeting the requirements for dog Judging and obtained my Working Group status in 2022. I am currently on permit for half of the breeds in the Herding Group and hope to complete this Group in 2024.

# Rules and Regulations

## GENERAL INFORMATION AND REGULATIONS

### **ATTENTION: building opening/closing times – open 6 am sharp, and close at 11 pm sharp**

1. Dog Show Rule books and Obedience/Rally Trial regulations are available from the Canadian Kennel Club.
2. The Show Superintendent will be in full charge of the show which will be governed by CKC rules.
3. ENTRIES WILL BE ACKNOWLEDGED BY EMAIL after entry closing, with receipt, judging schedule and exhibitor passes. If such acknowledgement is not received one week before the show date, please contact the Show Secretary.
4. “It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities” – CKC rule book, Section 19.7.
5. ENTRY FEES SHALL NOT BE REFUNDED AFTER THE CLOSING DATE in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee, or because it has been entered incorrectly. If because of riot, civil disturbance, or other acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.
6. ALL DOGS MUST BE KEPT ON LEASH WHILE ON THE GROUNDS. You are responsible for cleaning up if you permit your dog to relieve itself outside the show building. Failure to do so may result in being expelled from the building for one day’s showing by the Superintendent.
7. All empty rings are to be kept free of dogs.
8. SHOW PRECINCTS Show precincts will be entire AG Building at Stampede Park
9. “ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES.” If not in competition the dog must wear a collar and be on leash a maximum of six (6) feet or appropriately confined in the benching area.

## EXTRACTS FROM THE DOG SHOW RULES - BREEDS, CLASSES, AWARDS AND STAKES

### CONFORMATION CLASSES OFFERED:

12.2.1 Regular official classes at a CKC conformation show shall be as described in (a) to (k) of this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

**JUNIOR PUPPY:** shall be for dogs at least six months of age and under nine months of age on the day of the show.

**SENIOR PUPPY:** shall be for dogs 9 months of age and under twelve (12) months of age on the day of the show.

**12-18 MONTH:** for dogs over 12 months of age but under 18 months of age.

**CANADIAN BRED:** shall be for dogs born in Canada, Champions of any country excluded

**BRED BY EXHIBITOR:** shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class but need not handle the dog for further awards.

**OPEN CLASS:** shall be for all dogs.

**SPECIALS ONLY:** is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2-point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

### UNOFFICIAL/NON-REGULAR CLASSES OFFERED

**BABY PUPPY** Dogs 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

**VETERAN** In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

**RESERVE BEST IN SHOW:** will be selected from the remaining 6 Breeds competing for BIS

Novice A, Novice B, Novice C, Novice Intermediate, Open HA, Open HB, Open 18A, Open 18B, Utility A, Utility B, Pre -Novice, Exhibition Only

Novice A & Novice B, Intermediate, Advanced A & B, Excellent A & B, Masters, Exhibition Only

A Canine Companion Number allows mixed and unrecognized breed dogs to participate in the CKC Performance Events of Agility, Obedience and Rally Obedience Trials. The CCN Application form and information on requirements are available at [www.ckc.ca](http://www.ckc.ca) (other Show and Trial Forms).

See **OBEDIENCE & RALLY OBEDIENCE TRIAL RULES AND REGULATIONS** for complete information on classes.

## CHAPTER 4 – JUDGES

SECTION 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques “Payable in Canadian Funds” or “At Par”. They will not be cleared by the banks. To simplify the process, we urge that you pay by credit card, bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

**Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season** after the close of entries if a Veterinarian’s Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the Show Secretary **before the starting date and the time of the trial**. The Club will refund entry, recording and listing fees if the above conditions are met. No Refunds will be given for the service fees provided by the dogshow.ca

**A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian’s certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials for performance events ONLY. The bitch must be available to be examined by the Show Superintendent to verify she is in season.**

EVENT REGISTRATION NUMBER Effective Jan/1992 all dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number but will require an ERN - Event Registration Number. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. **Cost is \$64.00.** ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT. A CKC ERN registration form can be downloaded from the CKC website: <http://www.ckc.ca>

#### CKC Non-Participation Fee:

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) *"these fees apply only to dogs wholly owned by Canadian resident non-CKC members and are not applicable to CKC members"*

\*Please note that the CKC Membership Application and the Non-Member Participation Fee forms are available on the website, <http://www.ckc.ca> under CKC Services and then Forms On-line. If submitting a Membership Application, please ensure that you also complete the Non-Member Participation Fee form so that we are aware of the dogs involved. **This fee does not have to be paid before entering this show.**

**Entries sent by Courier must be sent prepaid, no signature required;** To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing time and date. **Please allow ample time for delays in the mail.**

**Exhibitors Please Note:** An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone, but **written or electronic notification must be received by the show secretary not later than closing date and time.** If written or electronic notification is not received, the dog will remain entered in the show.

The Evelyn Kenny Kennel and Obedience Club reserves the right to refuse any entry subject to CKC Conformation Show Rules and Regulations (8.6.1). In consideration of the acceptance of this entry, I (we) agree to be bound by the rules and regulations of the Canadian Kennel Club and by any additional rules and regulations appearing in this premium list.

I (we) agree to hold the Evelyn Kenny Kennel and Obedience Club, their members, directors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim.

I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

An "In Transit Area" for owner/handlers who are transporting dogs not entered in the show is offered. The dog's information and reason for its presence must be recorded with the Show Secretary and identifying information attached to the dog's crate.

Please note: Dogs shall be exercised only in specified areas provided by the Club. Private exercise pens will be limited.

Dogs should arrive in adequate time for their breed judging (allowing for absentees). It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds' conflict.

The Evelyn Kenny Kennel and Obedience Club will not allow the use of spike or pinch collars on its show grounds. If because of riot, civil disturbance or other acts beyond the control of the Evelyn Kenny Kennel and Obedience Club, it is impossible to open or to complete the show, no refund of entry fees will be made.

The welfare of an exhibitor's child is the responsibility of the exhibitor. It should be understood that exhibitors will exercise control and restraint over their children. The Evelyn Kenny Kennel and Obedience Club will not be responsible for injury to any child whether by accident or any other cause.

**ERRORS IN ENTRIES** An error in an age-specified class, date of birth or sex, may be amended up to one hour before the start of the show

Please note: **The show is a public event, candid photos and/or videos may be taken on the show premises. Such images may be published in print or on a website without your consent. By entering this dog show, you waive all rights to such images and agree that the Evelyn Kenny Kennel and Obedience Club shall not be held responsible for their use.**

#### MOVING A CLASS DOG TO SPECIALS

A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a championship in accordance with these rules but at the time of closing of entries for the show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner/handler at least one (1) hour prior to the opening of the show. When one or more all-breed championship shows and/or specialty shows are held on the same date in the same venue, the request for moving of class dogs to specials must be made a minimum of one (1) hour prior to the scheduled start of the show for which the dog is being moved up to.

**Please Note – the drive-in doors (overhead garage doors, or oversized sliding barn doors) can not be opened at any time through out the show weekend. There will be 1 Designated garage door that can be opened at the end of each day (after Best in Show), and at lunch on Sunday. Anyone who is found to be removing tape or signs from the doors, or propping man doors open, will be removed from the show, with no refunds given.**

**Extracts From CKC Dog Show Rules**

**Chapter 8 Entries and End of Show Section**

**8.2.5** An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

**Section 8.3.1** Entries: Every dog entered in a Championship show must be one of the following:

- a) registered with the CKC,
- b) have an Event Registration Number,
- c) be eligible for registration with the CKC, or
- d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

**Section 8.4.1** Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- b) that if born in Canada, it is eligible for individual registration;
- c) that if not born in Canada, is eligible for registration in the records of the CKC.
- d) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

**Section 8.4.2** Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

**Section 8.5.1** Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

**Section 8.5.3** No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

**Section 8.5.4** After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

**Section 8.6.1** Refusal of Entries: The authorities of any show may:

- a) decline to accept entries for just cause, and/or
- b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- c) in the case of non-acceptance, refund the fee with the reason for non-acceptance.

**Section 8.8.2** Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

**Section 8.9.1** Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

**Section 8.9.2** If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

**Section 8.9.3** When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

**Chapter 4 Judges Section 4.1.3** A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

**Section 4.1.5** No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

**Chapter 14 Disqualifying or Excusing Dogs**

**Section 14.1.2** (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

**Section 14.1.4** Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until

the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. A dog disqualified under section 14.1.2 (b) is not eligible for reinstatement.

**Section 14.1.5** Any dog that is disqualified under section 14.1.2(a) shall automatically be disqualified from entering in any CKC event in any other discipline until such time as the dog is officially reinstated, if the dog is eligible for reinstatement.

**Championship Points and Cancellations**

**Section 15.1.1** A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

**Section 15.1.2** The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs competing*	1	2	3-5	6-9	10-12	13 & more
Points allocated	0	1	2	3	4	5

*\*Includes the dog awarded Winners.*

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

**Section 15.1.3** If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

**Section 15.1.4** If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

**Section 15.1.5** If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

**Section 15.1.6** If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

**Section 15.1.7** The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

**Clarification:** Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

**Section 15.1.8** In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

**Section 15.1.9** A dog may not be credited with more than 5 championship points in a single show:

**Section 15.1.10** A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

**Section 15.1.11** A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

**Section 15.1.12** In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- (a) earn at least 10 championship points under at least 3 judges; and,
- (b) be individually registered in the records of the CKC or have an Event Registration Number.
- (c) have earned at least one 2 point win either at the breed or group level.

**15.2 Grand Champion (GCh)**

15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

**(a) Grand Champion Point System**

Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

(b) the following schedule shall be employed in determination of points awarded at Group Level for all GCh:

c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

(d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

Win	Points
Best in Show	5
Best of Breed at a National Specialty Show	5
Reserve Best in Show	4
Best of Breed at a Specialty Show (other than National)	3

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

**15.3 Grand Champion Excellent (GChEx)**

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

NOTE: 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

**Please Note – the drive-in doors (overhead garage doors, or oversized sliding barn doors) can not be opened at any time through out the show weekend. There will be 1 Designated garage door that can be opened at the end of each day (after Best in Show), and at lunch on Sunday. Anyone who is found to be removing tape or signs from the doors, or propping man doors open, will be removed from the show, with no refunds given.**
