Further, this rule also includes a club official, volunteer, or any participant at our events.

Entries will not be accepted unless accompanied with proper funds. Telephone entries cannot be accepted. Tendering of an NSF cheque in payment of entry fees shall be considered non-payment of entry fees. Credit cards that have maxed out shall be considered an offense punishable by disciplinary action and cancellation of awards by the CKC. \$35 will be charged for NSF cheques or credit cards which are declined for any reason. Our club will report any offense to the CKC. Overpayment of Fees will be gratefully accepted as a donation to our Trophy Fund.

ATTENTION FOREIGN EXHIBITORS Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. BRED BY EXHIBITOR AWARD

Anyone wishing to compete for the Best Bred by Exhibitor Class in Shows 3 and 4 on Saturday, June 16, you MUST BE entered in the Bred by Exhibitor Class or the Specials Only Class. If entered in the Specials Only Class, you MUST NOTIFY the Ring Steward prior to the judging of the Breed

JUNIOR HANDLING Sat, June 16 and Sun, June 17 Judges – TBA

All dogs handled must be entered in this competition must be entered in one of the Official Classes or for Exhibition Only on the day of the event.

Rosettes and Prizes will be awarded for first placement in each class and the Best Junior Handler Overall.

Regular Conformation Classes	
Junior Puppy	A dog between 6 months and under 9 months on the day of the show
Senior Puppy	A dog between 9 months and under 12 months on the day of the show
12-18 Months	A dog between 12 months and under 18 months on the day of the show
Canadian Bred	A dog which is born in Canada
Bred by Exhibitor	A dog(s) owned and handled in the ring by the breeder. The handler must be owner/co-owner AND breeder/co-breeder of the dog. The owner/handler must handle the dog in this class, but need not handle the dog for future awards.
Open	For all dogs.
Specials Only	For dogs who are Canadian Champions only.
Exhibition Only	Dogs entered in this class may not compete in any regular class but may enter and compete in Non-Regular classes and/or Parades if provided for in the premium list on payment of the prescribed Exhibition Only fees stated in the premium list.
Non-regular Classes	
Baby Puppy	A dog between 3 months and under 6 months of age on the day of the show. Winners of this class do not compete for points. The class is judged after the judging, after Group judging and prior to Best in Show judging.
Veterans	In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are Best Male Veteran and Best Female Veteran, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.
Altered	This class shall be for any spayed or neutered dogs over the age of 6 months of age
Brace	This class shall be for 2 dogs of the same breed (not necessarily of the same sex). A brace should be judged as an identical pair – same colour, size, gait, and same stride. When viewed from the side they should appear as one dog and its shadow. A Brace must be handled by 1 person on 1 lead
Order of Judging: At breed level judging of these classes will be after Best Puppy in Breed, after Best Puppy in Group and before Best in Show in the following order: Baby Puppy, Veterans, Altered, Brace	

CHAMPIONS AND CHAMPIONSHIP POINTS

A dog awarded WINNERS at a Championship show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded WINNERS shall be as provided hereunder. The schedule to be employed in the determination of the number of points awarded WINNERS shall be as follows:

Competing*	1	2	3-5	6-9	10-12	13 or more
Points	0	1	2	3	4	5

*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall **NOT** be included in the calculation for championship points. If a dog awarded WINNERS is also awarded BEST OF BREED at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total. If a dog awarded WINNERS is also awarded BEST OF OPPOSITE SEX to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total. If a dog is awarded WINNERS is also awarded BEST OF WINNERS, then all dogs defeated directly or indirectly in the breed shall be included in the total. If a dog is awarded WINNERS only, then all the dogs of the same sex in the class competition shall be included the total. The number of championship points to be credited to a dog awarded WINNERS shall be determined by the highest award earned and calculated as per Section 15.1. In addition to championship points allocated at the breed level, a dog awarded WINNERS, which also places in the regular Group competition, shall be credited with the following additional points provided that a dog was defeated at the Group level.

A dog awarded WINNERS which also places BEST IN SHOW at an All-Breed Championship Show shall be credited with 5 Championship points inclusive of any points earned at the breed and group level. In no case can a dog earn more than five points at a single show.

An error in the class, date of birth or sex may be amended on the entry form up to one hour BEFORE the start of the SHOW

EXTRACTS FROM THE DOG SHOW RULES

CHAPTER 8 - ENTRIES & ENTRY FEES

8.7.1 Withdrawal of Entries: An Exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone, but either written or electronic notification must be received by the show secretary no later than the official closing date and time as stated in the premium list. If written notification is not received, the dog will remain entered in the show.

8.8.2 Tendering of a dishonoured cheque or declined credit card in payment of entry fees shall be considered non-payment of said entry fee and is an offence punishable by disciplinary action and cancellation of awards.

CKC RULES EFFECTIVE JANUARY 1, 2018

3.3.1 - Substitute Judge – When a show-giving club is notified prior to the opening of the show that an advertised judge will not be able to fulfill his assignment, permission from the CKC to substitute the judge is required. Exhibitors affected by this change may withdraw their entries up to (1) one hour before **the judging of the breed**, notice of withdrawal must be made in writing. All entry and listing fees for withdrawn dogs shall be refunded. An exhibitor may enter a dog under the replacement judge providing that the dog is entered in one (1) of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees, will be accepted by the Show Secretary up to one (1) hour prior to the start of the show.

8.2.5—An error in the age-specified class, date of birth or sex of the dog may be amended on the entry form up to one (1) hour before the start of the show.

8.5.8—In case of a judge change (substitute or overload), an exhibitor may enter a dog under the replacement judge providing that the dog is entered in one of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees will be accepted by the Show Secretary up to ONE hour PRIOR to the start of the show (see sections 3.3.1, 3.5.1 ,8.5.4)

8.9.3—When one or more all-breed and/or Specialty shows are held on the same day, in the same venue, the request for moving of a class dogs to Specials Only must be made a minimum of one (1) hour prior to the scheduled start of the show for which the dog is being moved up to Specials Only.

12.4.1 Except for Puppy in Group or Show, an owner or handler shall be subject to disciplinary action for withholding a dog from competition for higher awards for which that dog is eligible. Any dog so withheld or absent will result in the cancellation of all awards won at that show (unless the dog is excused by the Show Superintendent).

SHOW RULES AND GENERAL INFORMATION

1. Showing correct information on the entry forms is the responsibility of the entrants. The show committee reserves the right to refuse any entry subject to the CKC rules. Entry forms must be the same size and format as those included or they will be rejected.
2. No entry will be accepted unless accompanied by entry fees. Telephone entries WILL NOT be accepted. Email or fax entries will be accepted provided that they are on a recognized CKC entry form and are signed by the exhibitor or agent.
3. Post dated cheques ARE NOT acceptable. Tendering an NSF cheque or declined credit card as payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. A \$ 25.00 NSF SERVICE CHARGE WILL BE LEVIED ON ALL NSF CHEQUES AND INVALID OR DECLINED CREDIT CARDS
4. Entry fees WILL NOT be refunded in the event that the dog is absent, sick, lame, excused by the veterinarian or judge or barred from the competition because it has been entered incorrectly.
5. Withdrawal of entries prior to closing date: 8.7.1 An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone, but either written or electronic notification must be received by the show secretary no later than the official closing date and time as stated in the premium list. If written or electronic notification is not received, the dog will remain entered in the show.
6. The entry of a dog cannot be altered or cancelled after the entries close, except as provided by the Dog Show Rules.
7. After the closing of the entries, an identification/receipt will be emailed to each exhibitor or agent. **Judging schedules may be downloaded at www.DogShow.ca within a reasonable time after closing date.**
8. ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES.
9. It shall be the duty and obligation of the show giving club to see that a judge, club official, ring steward, volunteer, or competitor at the Show held under these regulations, is not subject to any indignities of any kind. The Show Committee shall promptly report to the CKC any infringement of this regulation, and the discipline committee shall have the authority to take action as it deems fit on receipt of a report indicating that this has occurred.
10. The Show Committee will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for or assume any liability in the event of an accident or other misfortune to either the dog, exhibitor or patron. The Show and Trials giving Club will not be liable for any loss or injury that may be sustained through the disappearance, loss, theft and/or death of dogs entered in the show under any circumstances.
11. If, because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to compete the show, no refund of entry fees will be made.
12. EXHIBITORS PLEASE NOTE: **CKC RULE Discipline –Conformation Rule Book 19.7 -It shall be the duty and obligation of the show giving club to see that a judge, official, volunteer, or and participant at an event held under these rules is not subject to indignities. The Conformation Show Committee shall promptly report to the CKC any infringement of this regulation and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**
13. ACCORDING TO CITY BY LAW, DOGS ARE NOT ALLOWED OFF LEAD WITHIN CITY LIMITS. Exercise dogs only in the designated areas. Anyone not following STOP AND SCOOP POLICY will be excused from the shows and trials. Exhibitors are responsible for cleaning up after their own dogs, both inside and outside the show building. The Show Superintendent reserves the right to eject from the show anyone at the show who does not clean up after their dog.
