- Bitches in season will not be eligible to compete and are not allowed on the test grounds.
- **This is a Sanction Match – dogs/handlers with qualifying scores will NOT earn a title**
- Ducks, pheasants, and/or pigeons will be used.
- A draw for running order will be held at the home of the Test Secretary
- It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- By attending this test, competitors and spectators acknowledge that the Alberta Clipper Hunting Retriever Association, test officials, and landowners involved do not accept liability for any loss, damage, or injury incurred by participants, dogs, or spectators.

ENTRY

Listing fee: An \$8.82 (including GST) listing fee as established by the CKC must accompany the entry of a dog for which no valid CKC individual registration, ERN, or PEN is shown on the entry form.
