JUDGE BIO

Thank you for inviting me to share in this exciting day! I am honored to be a part of it and look forward to judging your beautiful dogs in the ring.

I have owned, raised, shown, and worked Alaskan Malamutes under the Winterchill prefix since 1980 and am a Life Member of the CKC. For the last three decades, Winterchill! Alaskan Malamutes have been top contenders in their fields, whether it is in the show ring or on the trail. I have produced Multiple Best in Show Winners, Multiple Best in Specialty Show Winners, Best Puppy In Show, and National Specialty Winners. In 2012, "Cruz'er" – MBIS MBISS A/C GChEx Winterchill's Cruz'n Spirit RN and I were invited to attend the Westminster Dog Show in New York. This was the first time a Canadian Bred Alaskan Malamute has ever achieved such an invitation; and it was a huge honor for me as his Breeder, Owner, and Handler. In 2016; BIS UK Ch BPIS Can Ch Winterchill's Task Force made breed history by being the first ever Canadian Bred Malamute to earn a UK Championship and I was fortunate enough to pilot him to his crowning CC at the Scotland Kennel Club show in Edinburgh, Scotland.

I worked as a Veterinary Technician and in the Pet Health Insurance industry for over 25 years and have been an active member of the purebred dog fancy for over 40 years. You could easily say that animals are my passion in life.

CKC rules governing this match:

- 16.2.1 Only recognized or listed breeds may compete (no listing fees need to be paid
- 16.2.3 Dogs entered must be handled by the owner or member of his family or a person who DOES NOT receive any monetary consideration

Please be responsible for your dog. For the safety of all dogs and exhibitors we ask that you keep a diligent eye on your dog always. Outside the ring we ask that you keep your dog in a crate or on a short leash and under control.

FAILURE TO PICK UP AFTER YOUR DOG OR ALLOWING IT TO URINATE ON THE TRIAL PRECINCTS OUTSIDE OF THE DESIGNATED AREA, INCLUDING THE BUILDING, STEPS, RAILS, ETC. WILL RESULT IN DISMISSAL FROM THE MATCH
