Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specification.

No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time. No choke, pinch or electronic collars allowed on site at any time.

It is expressly understood that competitors alone are responsible for the behavior of their dogs and / or children. Any competitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and NO REFUND of fees shall be given.

All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disgualified and / or required to leave the show grounds and NO REFUND of fees shall be given.
