## **OBEDIENCE TRIAL RULES**

- 1. The Obedience Trial Chairman is in complete charge of the Trials.
- 2. No dog will be allowed in the building or on the grounds unless entered in the trials.
- 3. No dog is to be left off leash at any time on or near the grounds of the trials except in the obedience rings.
- Violation of this rule can result in dismissal from the competition. No refund shall be made.
- 4. Exhibitors must wear the correct number while in the ring.
- 5. Obedience fees for bitches in season will be refunded upon the provision of a valid veterinarian's certificate proving same.

## **GENERAL RULES**

- 1. No dog will be allowed to compete unless entry fees have been paid.
- 2. The Trial Committee has the right to refuse any entry subject to CKC rules.
- 3. The Club will use due diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune, to either dogs exhibitors or patrons.
- 4. A judge officiating at the Trials under the Obedience Trial Regulations and Standard shall not be subject to indignities of any kind during the progress of the trials. It shall be the duty of the Club holding the show to see that this rule is effectively carried out. The Trial Chairman shall promptly report to the Canadian Kennel Club any infringement of this rule. The Board of Directors shall have the power to take action as it deems fit on the receipt of a report indicating that this rule has been violated.
- 5. If because of riot, civil disturbance or other acts beyond the control of the Trial holding club, it is impossible to open or to complete the trials, no refund of entries will be made.
- 6. Fees must accompany your entries. Tendering a NSF cheque shall be considered an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$ 15.00 fee charged for any NSF cheques issued. No post-dated cheques accepted. Overpayments will be donated to the trophy fund.
