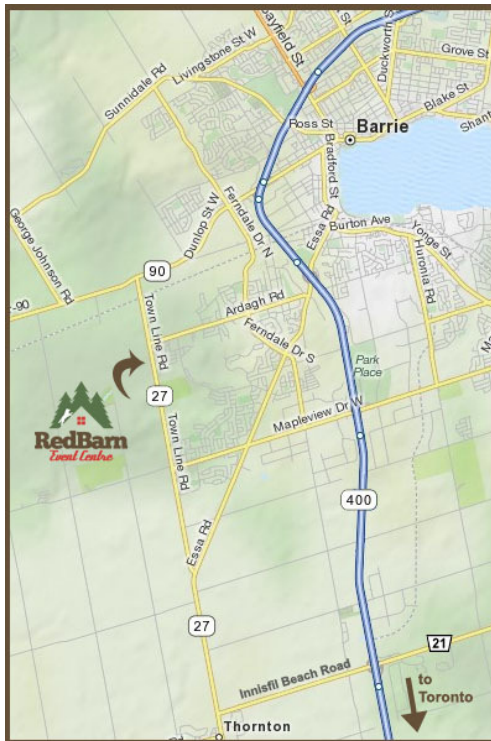

The Red Barn Event Centre:

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thorton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you've gone too far.

	** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.		

General Information	The Secretary and Superintendent is in full charge of the Trials. The show precincts shall consist of the agility building. Food and toys are not permitted in the course area and handlers are not permitted to use whistles, clickers, flexis or other instruments or devices in the ring or within the building. Bitches in Season are also NOT permitted any where at the trial venue. Dogs must be ON LEASH at all times when outside the ring, in the building as well as on the trial grounds.
Event Information	Agility ring surface is Top Dog rubber agility flooring with underlay. Agility handlers in all classes will be able to walk their course, without their dog prior to the start of the class. Handlers must be ready at the start line when called or risk forfeiting their run. If a dog is not at ringside after it has been called 3 times, it will be marked absent. Please advise us ASAP if you have a conflict and we will accommodate your needs.
Obstacles	Obstacle familiarization will be available for Novice classes immediately prior to the first Novice Standard class. Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2014.
Eligibility	To be eligible to compete in the <u>agility trials</u> , a dog must be 18 months of age. ALL dogs my be registered or be eligible for registration with the CKC, have an ERN or CKC Miscellaneous Certificate or Performance Event Number (PEN) or CKC Mixed Breed Number to compete in agility. Spayed bitches, debarked dogs, and neutered males are eligible to participate.
Bitches in Season & Refunds	Bitches in season <u>may not compete</u> . When a bitch comes into season after the entry has closed a Veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trial must reach the secretary on or before the start of the trial. A full refund of entry fees and listing fees will be given. However, if a credit card was used, the processing fee will not be refunded.
Trophies	Ribbons will be given for 1st through 4th qualifying scores in all Jump Heights in Agility trials . ***NEW***To prevent an increase in entry fees, New Title Rosettes will be available at a cost of \$6.00. Tabs with the title name are still no charge.

**Non Member Participation Fee
\$57.60 + HST**

A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.

The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

HELP WANTED for Agility Trials

Without the help from volunteers, we could not host these trials. We cannot do it alone! We need your help to make our trial a success. PLEASE sign up to work at the registration desk at the trials.

Job Descriptions

Gate Steward: Makes sure exhibitors are at the gate, in the correct order and ready to run

Ring Steward: Sets bars to correct positions prior to each jump height in a class. Re-set dropped bars, straighten chute

Leash Runner: Takes exhibitor's leash from start line and places it at finish

Scribe: Marks faults on scribe sheet as they are called by the judge

Timer: Times the dogs' runs using electronic timing

Course Builder: Assists the Chief Course Builder with putting obstacles in the correct position as indicated by the judge

Are you in the correct Class, please note changes?

Selected Class: Any dog eligible to enter an agility trial may enter the Selected Class. Once a dog has been designated as a Selected and entered in this class, the dog cannot revert/transfer back to the Regular or Selected Classes. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one jump height lower than its Regular jump height and get 10% more time than the STC.

Novice is for dogs that have never acquired a CKC agility title in that class. Dogs may continue to compete in Novice once they have acquired that title, but must be moved up once they have a leg in Intermediate in that class.

Excellent is for dogs that have acquired the Intermediate title, but have not yet earned the Agility Excellent title in either Standard or JWW.

Master Excellent (formerly Excellent B) is for dogs that have acquired the Excellent title or the Master Excellent Title. A dog may move up into Master Excellent in only the Standard or JWW class that they have earned an Excellent Title in. A dog only needs to be entered in Master Excellent for the class that he/she has achieved the excellent title in. ie. A dog can be in Excellent JWW and Master Excellent Standard.

Veteran Class: a dog 7 years of age or older may be entered in the Veterans Class. Once a dog has been designated as a Veteran and entered in this class, the dog cannot revert/transfer back to the Regular or Selected Classes. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one or two jump heights lower than its Regular jump height and this class will get 10% more time than the Regular Standard course time.

For full rules on these classes please refer to the Official CKC Agility rule & regulations.
