Thunder Bay Kennel & Training Club Rally & Obedience Trials

March 25 - 26, 2023

Welcome to all participants and judges.

We are looking forward to a fun time at our doggy performance event.

These trials are held under the rules of the Canadian Kennel Club

Canine Coaching Club will be open at 7:00am each day.

The trial begins at 8:00 each day and the Trial times are located on the attached schedule. (an “unofficial” approximation of start times will be found at the end of this note)

Due to the flight times, there will be NO Day-Of entries available.

Just a few additional rules and reminders to keep things rolling along and to ensure that the facility will invite us back.

- **Dogs must be crated at all times** or kept in your vehicle except when they are performing or when they are in the warm-up/ready ring. Please place your crate in the designated area and be ready to share the space, we do not have enough room to allow for people to spread out. This means put your chair in front of your crate, not beside it.
- Be sure to be on time for your event and be ready to enter the ring when your number is called.
- A small warm-up/ready ring will be marked out and the next dog in the ring will be given priority.
- **Remember to pick-up after your dog.** Please potty your dog at the North end of the building. The entranceway and the Nadin Construction lot are **NOT** potty areas. There are garbage cans outside for your use.
- **Remember to pick up after yourself!** If you spill it, clean it up. If you drop it, pick it up. Our use of the facility is precious. CCC and the trial organizers thank you in advance.
- Owners are responsible for crate outbursts or continuously distracting noise by their dogs and will be asked to closely monitor their dogs or remove them to wait in a vehicle.
- The trial precincts are the entire Canine Coaching Club facility including the parking lot. **All** CKC rules apply, whether inside or outside the trial precinct. The Superintendent is fully in charge of the trial.

- Canine Coaching Club is located on a working construction business site. **DO NOT** drive above **5km/h** once you pass through the gates; this is for the safety of their employees, equipment, and our dogs. As the Nadin site is a private business, **we do not have permission** to be walking/exercising dogs through their work areas; that includes walking down the roadway from CCC. If you wish to “walk your dog” you must leave the site in your vehicle.
- Please be prepared to follow CKC rules as prescribed in the Obedience Trial & Rally Obedience Trial Rules and Regulations, 2021 book.
- **It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an Obedience Trial held under these regulations is not subject to indignities of any kind.**
