### Notice to All Canadian Residents Only New CKC Rule

#### Section 24-12-3, Non member participation fee

- (a) An annual non member participation fee for awards and titles will be charged to a Canadian non member of the CKC.
- (b) In order to protect the awards/titles earned, the non member will have a choice either to become a CKC member or to pay the non member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

Trial precincts shall be the interior of the **Canine Development Centre**. The Superintendent will be in full charge of the trial, which will be governed by CKC rules. The Thunder Bay Kennel & Training Club and the Trial Committee will use care and diligence for the welfare of all dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of an accident or misfortune, however caused. If because of riot, civil disturbance or other acts beyond the control of management, it is not possible to open or complete the trials, no refund of entries will be made. Refunds will be made when a bitch entered in the Trials comes into season after entries close if a Veterinarian's certificate is delivered to the Event Secretary before the date of the trial. Entry fees will not be refunded should a dog be absent, sick, lame or excused by a Veterinarian, Judge, or Superintendent. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. The exhibitor is responsible for knowing and complying with the CKC Obedience Rally Trial Rules. It shall be the duty and obligation of the Trial club to see that the judges, club officials, ring stewards, volunteers or competitors at the Trial held under these regulations are not subject to indignities of any kind.

***It is the responsibility of the exhibitor to familiarize himself with the CKC rules and regulations.***
