Section 18.7 CKC WC Test Rules and Regulations

It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at the hunt test held under these regulations, is not subject to any indignities. The WC Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
