No cover will be provided in case of inclement weather.

GENERAL INFORMATION

“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred”.

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 18 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. A dog may be spayed, neutered or debarked.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made. Entries will be accepted only if accompanied by the correct fees. Courier entries will be accepted if no signature required. Tendering of an NSF cheque is considered non-payment of fees and is punishable by disciplinary action. A \$40 NSF service charge will be applied. Move ups will be allowed if received 1 hour prior to the trial starting. Flat carded & stringed ribbons will be awarded for qualifying scores & 1st through 4th placements. Title ribbons will be provided.

CKC Non-Member Participation Fee / Non-member participation fee

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC (\$63.90). The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
