Scratches: Entry fees will be fully refunded for a bitch in season. All other scratches will be refunded at the Field Trial Committee's discretion, minus an administration fee of \$10.

Please note: Canadian resident non-CKC members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC.

Dead Ducks, Pheasants will be used at this trial. Males and females will be run in order of the draw. A system of rotation will be used for the start of subsequent series in the All-Age Stakes. Wingers may be used in all stakes. Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial. Eliminated dogs will be allowed to run out of contention in the minor stakes as time allows.
