GENERAL INFORMATION

“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred”.

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. *See below for TCN numbers. A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, in the opinion of the judge; they display no signs of physical discomfort and can safely complete the search.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered – Instinct, Novice and Open (Containers, Interior and Exterior). Limited class entries.

Exhibitors CANNOT compete in the same component with multiple dogs. ALL levels will be limited. Move ups will be unavailable on the day of the trial

Scent Detection Prize List - Flat ribbons will be given for all qualifying scores. Titling Rosettes will be available.
Prize for fastest time in Instinct.
Prize for fastest combined time in Novice (containers/interior/exterior) (must qualify in all elements)
Prize for fastest Combined Time in Open (containers/Interior/exterior) (must qualify in all elements)

Penalties issued by club - Dropping food while rewarding is considered a contamination. Contamination of the search area will result in a non-qualifying score and any dog who urinates, defecates or vomits within the search area will be excused from the competition.

A \$35.00 fee will be applied for tendering of a dishonored cheque for entry fees and shall be considered non-payment of entry fees.

CKC Non-Member Participation Fee / Non-member participation fee /TCN #'s

The new process requires all owners of unregistered, recognized breeds entering events to obtain a [Temporary Competition Number](#) (TCN). TCNs will replace the current system of entering events with dogs as “listed” and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

TCNs will be required to enter all events with closing dates after March 2, 2020.

Trial Procedures in Place During the COVID-19 Pandemic

Hello everyone! We are trying very hard to offer a safe and enjoyable experience. However, it is going to take the cooperation of everyone involved to make this a success. As a result, we are implementing the following. If you disagree with any of the rules please come back when things are back to normal.

COVID RULES:

1. STAY HOME IF YOU ARE FEELING SICK!!!! Here is the link to Ontario's COVID 19 Self-Assessment Tool: <https://covid-19.ontario.ca/self-assessment/> Please take the assessment on the morning of the event.
2. DISINFECT YOUR HANDS REGULARLY. Refrain from touching your face.
3. Follow all Provincial and Municipal guidelines with regard to COVID-19 precautions.
4. Please refrain from touching anything that isn't yours. Stay on guard against touching anything that may have been touched by others. Carry your own hand sanitizer or wipes – and USE THEM!
5. Maintain social/physical distance.
6. If you feel more comfortable wearing a mask, please bring your own. Provincial guidelines recommend wearing a mask when social distancing cannot be maintained. Please be advised that we will not be providing masks or gloves to competitors. **Masks are mandatory for each walk through.**
7. Gloves are an individual choice. Studies show frequent hand washing is better than gloves in many cases. If you do wear gloves be VERY aware of not touching anything else during that time. If you prefer to wear gloves, you will need to bring enough pairs for the times you will need to wear them. Please dispose of them immediately after use.
8. Spectators are not allowed. However, competitors may be accompanied by members of their same household but they must remain outside.
9. Please use hand sanitizer when entering the building and again when you leave . Hand sanitizer will be available on the outside of the entry and exit doors.
10. Bring your own food, snacks, water, drinks, etc.
11. Make sure your dog is ok with people wearing masks. We don't want a dog becoming fearful due to something they've never seen before.
12. Parking will be spaced to allow safe distances. Please check with attendant.
