Dogs are required to have a Barn Hunt registration number to compete in a Barn Hunt trial. Register your dog online at www.barnhunt.com. Allow at least 48 hours to receive a barn hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

Directions to the trial site:

From Thunder Bay, head south on Highway 61 towards the US border. We are located at 3020 hwy 61, just past the Thunder Bay Correctional Centre. We are the first driveway on the right hand side after GFL Canada. If you have reached DeBruins Nursery, you have missed the driveway. (We are directly across the highway from DeBruins Nursery)

From the US border, heading north on Highway 61 towards the city of Thunder Bay, we are approximately 45kms from the border. We are the first driveway on the left on the highway past DeBruins Nursery. If you see the Thunder Bay Correctional Centre, you have gone too far.

We will have 2 rings with one judge. 9 am is General briefing and judges briefing.

First dogs should be ready to go to the blinds at 9:15am.

Friday: Trial #1- Instinct, Novice, Open, Senior and Masters, with some breaks in between

Friday Trial#2 approximate start 3pm. Masters, Crazy 8's (in that order)

Saturday Trials # 3 & 4, will run concurrently, 2 Instinct, 2 Novice, 2 Open, 2 Senior, 2 Masters

Sunday Trial #5 Instinct, Novice, Open, Senior, Masters

Trial #6, approximate start is 3pm Masters, CZ8s

LOOK CAREFULLY AT THE RUN ORDER WHEN IT IS SENT OUT, SO YOU KNOW WHEN TO BE THERE AND BE READY.

Friday runs height order small to large, Saturday height order large to small, Sunday height order small to large. Dogs being handled by the same person will be separated into different staging areas. Move ups will be allowed trial to trial. Two regulation sized outdoor rings.

The running order and further scheduling details will be emailed to all exhibitors after the actual number of entries are known for each class.

Height divisions: Small—dogs 13" and under, Medium—dogs 13.1" to 18", Large—Dogs over 18"

Exhibitor Information:

Entry forms : can be created on the barn hunt site at www.barnhunt.com then printed or scanned and sent with your payment.

Entering and paying through Dogshow.ca will give you actual online entry for the trials without any other steps. The waiver will need to be signed and sent to the trial secretary or can be filled out at the trial.

Food & Drinks:

There will be a lunch break at the judge's discretion. Purchase of food will NOT be available on site.

Refunds:

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy or any other cause beyond the control of the organizing committee. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. If cancelled due to Covid 19, partial refunds MAY be given.

Dog must be ON LEASH at ALL times unless they are in the ring or crated.

We will be adhering to all restrictions in place for/by Tucker Creek Farms as well as all BHA rules.

The safety of the dogs and rats is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviour may, at the discretion of the trial committee, may be asked to leave the site. In that case, no refund of any fees paid will be made.

Exhibitors are responsible for being ready to go to the staging area when it is their turn to run. The judge need not wait for any dog holding up a class. Owners are responsible for any error made on entry forms, regardless of who may have made the errors.

Loud/Disruptive dogs:

Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Terrier sparring is not allowed on trial grounds. Any dog that is sick, injured or lame will be excused from the trial grounds.

NO CRATING NEAR RINGS, ALL TEAMS TO REMAIN AT CARS UNTIL CALLED

CRATING: All dogs must be on leash or crated at all times unless actively working, or going to or from the ring or being pottied.

Dogs can get excited at barn hunt events. Dogs must be securely crated at all times or with the owner and on leash. Dogs may not be left unattended outside of a secure crate.

Please pick up after you dogs and take your waste/garbage with you.

Always be mindful of leaving the grounds as you found them.

Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

Accommodation

All dogs should be crated in rooms.

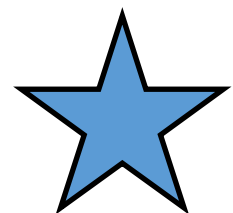

COVID-19 TEMPORARY RULES

Competitors entering Barn Hunt trials must comply with all Federal, State and Local laws regarding travel and attendance at non-essential events. It goes without saying that anyone who is quarantined and/or ill for any reason must stay home.

Entering and attending any Barn Hunt trial at any time is done entirely at your own risk. All Clubs will have a waiver that you must sign designating that you understand the risk you are taking by entering an event, that you are well and have not been in contact with someone with COVID-19 (or have a recent negative test, a recent positive antibody test, and/or are fully recovered and released to normal activities without restriction), and that you understand that the Club is not liable if you get COVID-19 at any time during or after the event. If a Club suspects a competitor is ill, they will ask for that competitor to leave trial grounds immediately.

Competitors should expect longer days at Events due to some of the extra steps Clubs and Judges must take to make sure Events are safe for all.

Withdrawing due to sickness:

Competitors who enter a scheduled Event but then must withdraw due to suspected or confirmed COVID-19 or direct exposure to a COVID-19 patient will receive a full refund minus a Club administration fee. That administration fee will be set by the Club but may not be more than \$10.

Masks/face shields and gloves:

All Event attendees must wear masks. Masks must be worn indoors, going to and inside the blind, going to the ring, and in the ring/exiting the ring.

If outdoors on trial grounds and not going to the blind/ring, masks must be worn any time a person will be within 10' of another person. Face shields are also allowed but must be worn in combination with a mask.

Competitors must provide their own masks/face shields in a sufficient number to make it through the event; the Club will not provide masks or face shields for competitors. If used, face shields must be cleaned/disinfected at least daily.

- Gloves are allowed but not required, • Face shields are a solid piece without holes, reach below the chin, to the ears, and the area between shield and forehead is covered. • Masks are of cloth or other permeable material without holes, covering both the nose and the mouth. A one-way valve (usually a raised plastic circle the size of a quarter), which aids in exhalation, is not allowed.
- Any person refusing to wear a mask or taking down/removing the mask within 10' of another person not in their household will be asked to leave the Event. Any person who becomes combative/disruptive about mask

wearing may be subject to a Trial Hearing on misconduct/lack of sportsmanship.
