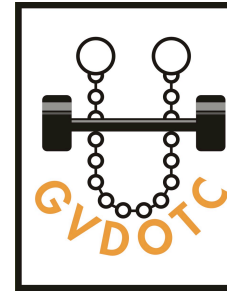

RULES GOVERNING THESE TRIALS

The Greater Victoria Dog Obedience Training Club will use all responsible care to ensure the safety of the dogs exhibited but will not be responsible for or assume liability for loss or injury to any dog or exhibitor. If for any reason beyond the control of the Club it is impossible to open or complete the trials no refund of entry will be made.

Dogs must be kept under control at all times and on leash at all times within the building and Fairgrounds with the exception of the obedience ring. No dogs will be allowed inside the Agriplex building during these trials unless officially entered with the exception of the Certified Assistance Dogs.

The Greater Victoria Dog Obedience Training Club reserves the right to remove any person from these trials. The Trials Chairperson and Superintendent shall have full control of the event which will be governed by the Canadian Kennel Club rules.

Exhibitors are solely responsible for the conduct and actions of their animals while they are on the show grounds. Please pick up after your dogs both inside and outside the building.

Every dog entered in an approved obedience trial must be one of the following: registered with the CKC; have an Event Registration or Performance Event Number; eligible for registration with the CKC; or, have a Miscellaneous Certification number if it belongs to a CKC listed breed (Sec 6.1.1)

Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called. (Sec 8.6.2)

The welfare of an exhibitor's child is to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children during these trials.

Any dog entered and received at an obedience trial must compete in all exercises of all classes in which it is entered, unless excused by the judge, official veterinarian, or the trial chair. (Sec 6.4.1)

Bitches in Season may not compete. Full refunds will be given for dogs withdrawn because of injury, illness or death and for bitches in season, if notification in writing is accompanied by a veterinarian's certificate. All refunds must be requested in writing and once the catalogue has been printed, will have the CKC event fees and listing fees, if applicable, deducted.

Any person either within or outside the judging ring who does anything calculated to attract, distract or otherwise affect in any way, the attention, deportment or performance of a dog under judgment, may be disciplined by the discipline committee in whatever way it considers in the best interests of GVDOTC, or the judge may take summary action.

Entry forms must be complete in every respect. Exhibitors must abide by any errors made in entering their dog.

The Club must reject an incomplete entry form and promptly return it to whoever submitted it, be it the owner, lessee, or authorized agent. (Sec 6.2.3)

The entry of a dog must be accompanied by the entry fees. (Sec 6.3.2) **Conditional entries or entries accompanied by post dated cheques will not be accepted.**

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards. (Sec 6.3.3)

It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Trials Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Sec 20.7)

Exhibitors should be familiar with the current Jan 1st 2012 Canadian Kennel Club Obedience Trials Rules and Regulations and the Jan 1st 2012 Rally Trials Rules and Regulations.

EXHIBITORS INCORRECTLY ENTERED IN AN "A" CLASS IN RALLY OBEDIENCE TRIALS ARE PERMITTED TO MOVE THE DOG TO THE CORRESPONDING "B" CLASS UP TO ONE HOUR BEFORE THE START OF THE TRIAL IF THE SCHEDULE ALLOWS. (6.9.7)

ATTENTION FOREIGN EXHIBITORS

PLEASE NOTE THAT ALL FEES ARE DUE AND PAYABLE IN CANADIAN DOLLARS. DUE TO CONSISTENTLY FLUCTUATING CURRENCY RATES, DISCOUNTED CHEQUES WILL NOT BE ACCEPTED. PERSONAL CHEQUES WILL BE ACCEPTED, HOWEVER, THEY ARE TO BE PAYABLE IN CANADIAN FUNDS. BORDER CROSSING

CANADIAN GOVERNMENT REGULATIONS REQUIRE THAT A DOG ENTERING INTO CANADA MUST HAVE A VALID RABIES CERTIFICATE. THE RABIES CERTIFICATE MUST BE DATED 30 DAYS PRIOR TO ENTRY.

EVENT REGISTRATION NUMBER (FOREIGN BORN/ FOREIGN OWNED DOG)

FOR THE PURPOSE OF ENTERING CKC EVENTS TO OBTAIN CHAMPIONSHIP STATUS AND OBEDIENCE TITLES AND DEGREES, INDIVIDUAL REGISTRATION IS NO LONGER REQUIRED FOR FOREIGN BORN, FOREIGN OWNED DOGS. FOREIGN EXHIBITORS MAY APPLY FOR AN ERN (EVENT REGISTRATION NUMBER). THIS NUMBER MUST BE APPLIED FOR WITHIN 30 DAYS OF OBTAINING POINTS, SCORES OR AWARDS TO AVOID CANCELLATION. EXHIBITORS MAY SUBMIT A PHOTOCOPY OF THE DOG'S FOREIGN REGISTRATION CERTIFICATE AND THE APPROPRIATE FEE (\$59.40 CANADIAN) ALONG WITH A LETTER OF REQUEST TO THE CKC. THIS ERN NUMBER REPLACES A CKC INDIVIDUAL REGISTRATION NUMBER FOR ENTERING CKC EVENTS ONLY.
