Entries and full payment for entries must be received by the secretary before the closing date & time. No day of entries will be accepted. Only paid entries will be entered into the draw for running order.

*Entries: Entries must be completely filled out and signed. Owners are responsible for errors on entry forms or where hand-writing is not clearly legible. No phone, faxed, emailed, late or day of entries will be accepted. A separate entry for EACH dog in EACH test is required on an official CKC entry form. ERN's (Event Registration Numbers) for foreign born or foreign owned dogs can be obtained from the CKC or Field Trial Headquarters. ERN's must be applied for within 30 days of entering a CKC event.

*Listing Fee: An \$11.30 listing fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration, Event Registration Number (ERN) or Performance Event Number (PEN) is not shown on the entry form.

GENERAL INFORMATION - MUST READ


- Rules: Retriever Trial Rules and Regulations Books are available from the Canadian Kennel Club, 100 89 Skyway Ave., Etobicoke, ON M9W 6R4. Note: To enter the Junior stake the dog must be between 6 months and 2 years of age on the day of the trial!
- Awards: Official CKC Rosettes will be awarded to all placements and qualifying dogs at the end of the field trial day.
- **Refunds:** Entry fees will not be refunded after Friday August 3rd. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Field Trial Committee or the Canadian Kennel Club, no refund of entry will be made. Bitches in season are NOT eligible for entry and are not allowed on the trial grounds. Bitches may be subject to vetting. Entry and listing fees paid for any dog withdrawn because of estrus, illness or death shall be refunded in full if notification in writing is accompanied by a veterinarian's certificate. All refunds must be requested in writing and once the catalogue has been printed, will be less CKC event fees and listing fees if applicable.
- **Running Order:** Running order will be drawn at the home of the Field Trial Secretary at the time and date of closing. Males and females will be run in the order of the draw or at the discretion of the Marshall.
- **Start Times:** Start times will be adhered to as strictly as possible and handlers are asked to be at their stake and checked in with their Marshall a minimum of 15 minutes prior to start time regardless of running order.
- **Clothing:** Spectators shall not wear white or distinctively light clothing at any time but handlers may wear a white handling jacket.
- **Birds**: Dead ducks will be used in each stake.
- **Grounds:** All dogs when not running in their test MUST be on leash and under control. Bring adequate shade, sunscreen, water and cover for hot or rainy weather for both you and your dog(s). Be prepared and carry a first aid kit. YOU MUST pick up after your dog and airing is only allowed in areas designated by Test Headquarters and Trial Marshalls. Please respect the landowners that have so graciously allowed us on their land by obeying all signs, removing all garbage and debris. Close all gates behind you and park ONLY in designated areas.
- Indignities: All participants must be familiar with Chapter 21, Section 7 of the Field Trial Rules and Regulations. In summary, it provides that any Person participating in a Trial shall not be subjected to an indignity of any kind. Violations of this rule shall be dealt with in accordance with the rules and regulations of the Canadian Kennel Club.
- <u>ALL Competitors & Spectators:</u> BY ATTENDING this Field Trial, competitors and spectators acknowledge that the Upper Island Retriever Club, trial officials and the Landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors, dogs or spectators.
- **Concession:** There will be no concession on the Field Trial grounds.

RETRIEVER TRIAL TEST HEADQUARTERS & CHECK IN TIMES

- IMPORTANT Check in: Please check in with the Field Trial Marshall at Test Headquarters Swamp Dog Farm, 7531 Albert Rd., Black Creek 30 to 45 minutes before start time. We ask everyone to drive SLOW on the roads leading to Test Headquarters and Field Trial locations. This is a farming community, watch for children, farm machinery, animals, farm dogs be aware and obey ALL posted speed limits.
