Attention Foreign Exhibitors – Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the bank. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

GENERAL INFORMATION

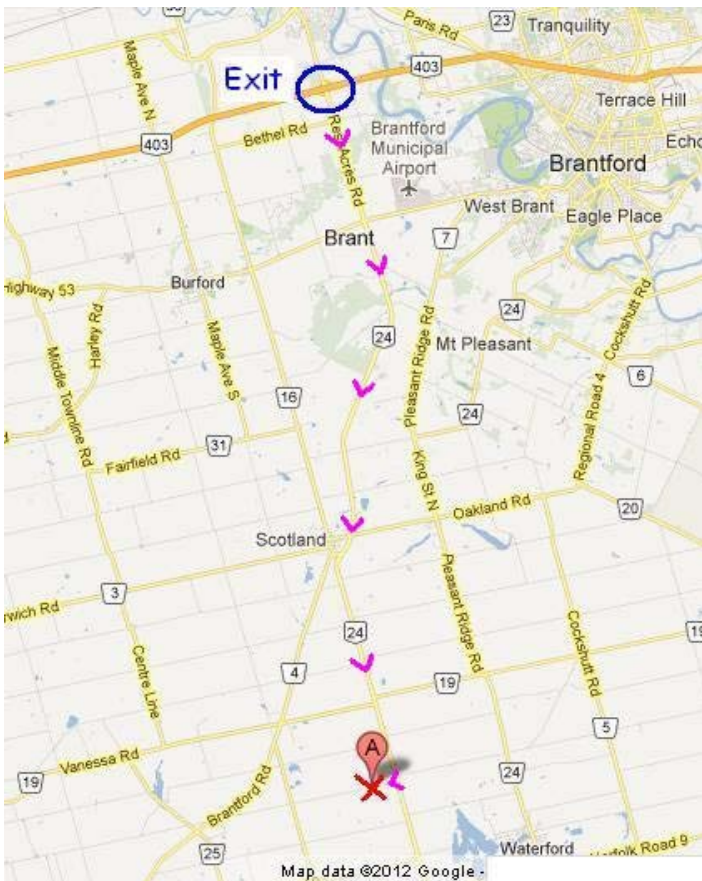
1. The **trial precincts** shall be all the grounds within the 80' x 125' enclosed grass rings.
2. E-Timers will be used.
3. Contact familiarization will be available to Novice dogs before the first Standard course of each day.
4. Move-up option: A dog may move up to the next class between trials on the same day, by filling in the required move-up form and handing it into the secretary.
5. Show Superintendent has full charge of the show which is governed by CKC rules.
6. The Poodle Club of Canada and The Poodle Farm will use **due care and diligence** for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
7. **"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an event held under these regulations, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. "**
8. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.
9. **CKC Non-membership participation fee** – i) A non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. ii) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. iii) In order for titles to be awarded, the non-member will have a

choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. iv) All Premium Lists will carry a note stating that these fees apply only to dogs wholly owned by non-member residents of Canada and are not applicable to CKC members.

10. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials.

11. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.

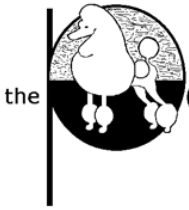
Directions from London:
