**Day of Show Entries:** - Dogs that enter performance events 1 hour before the trials begin will be judged within each class of competition but will be placed at the end of each class of competition. Dogs entered on day of show will not have their entry recorded in the catalogue. All dogs entering must be eligible for competition at the time of the trials as set out in the rules of the CKC and must possess a CCN number.

Junior Handling Conformation (Saturday) will be held in the first available ring at approximately 11:30 AM.

Junior Handling Obedience (Sunday) will be held immediately following the Obedience competition but before the Rally competition starts. Approximately 10:15 AM in the obedience ring. Judges for each event will be announced at the shows/trials on each day of competition. Entries for both events must be in the hands of the Show Secretary at least 1 hour before the competition. Cost is \$5.00 per Junior per event. Dog must be entered in a regular class in the shows or trials or entered as Exhibition.

## **From Avalon Kennel Club:**

The AKC will be hosting a <u>Silent Auction</u> on Saturday and Sunday. Closing of the Auction will be approximately 12::30 PM on Sunday. We would appreciate any new items or very gently used items that you would wish to donate. Also please be generous in your bidding !!!

<u>Set – Up</u> will be from 5:30 pm – 6:45 pm only on Friday night. No set up of individual places will be permitted until the rings are placed. You are welcome to come along and help with set up to get first dibs on good spots but only after the shows set up is complete.

This is a **self-clean show**. Product and cleaning materials will be available for your use both inside and outside of the venue.

The AKC will be having a **Show Social** at P.J Billington's at 7:00 pm on Saturday, October 4<sup>th</sup>. All are welcome to attend. Please see the show secretary on Saturday or contact Mary Dunphy. The ordering will be by menu and single invoices.

Buckmaster's Circle Rec. Centre have a few rules that we must adhere to:

NO sprays or other grooming products are to be used in the set up areas. All sprays and products must be put on the dogs outside of the venue. If you damage the floor beneath your set up you will be held responsible for its repair. Just a reminder that CKC tells us that dogs must be shown in their natural state without addition of any sprays, or products which alter or enhance the natural coats of the breeds.

NO smoking inside the venue or outside of the entrance/exit doors of the building.

Additional parking is available on Ricketts Road on Saturday and Sunday. Please do not block anyone's driveway in the area.

- On the day of the show/trial, the show/trial superintendent will be in charge of the show/trial which is to be governed by CKC Rules and Regulations
- Only dogs properly entered in the show/trial will be admitted.
- The building will be opened 1 (one) hour before the start of the show/trial.
- \_ Dogs may be removed from the building when not required for further judging. Dogs must not be left in the building overnight.
- \_ Dogs and their handlers should arrive in adequate time for their breed judging (allowing for absentees) and will be excused from each show when not required for further judging. It is the responsibility of the exhibitors/handlers to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs is not possible and handlers with several breeds must arrange alternate handlers if judging times for their breeds conflict. Judging will proceed without any dog not present when called by the ring steward.
- \_ The show/trial committee and the Avalon Kennel Club will use due care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, or assume any liability, in the event of an accident or other misfortunes to either dogs, exhibitors or patrons.
- \_ There is no security services provided at the venue, therefore, property left at the show/trial grounds is done so at the owner's risk.
- \_ If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show/trial, no refund of entry fees will be made.
- \_ We regret that trailer hook ups will not be available at the show/trial site.
- \_ It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation/Trials Show Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit upon receipt of a report indicating that this has occurred.
- \_ The show/trial grounds are defined as the confines of Buckmaster's Circle Recreational Centre, Buckmaster's Circle, St. John's, NL.
