

Directions to Tucker Creek Farm

From Thunder Bay we are 10.5 km south of the Airport, on Highway 61 towards the US border. The address is 3020, Hwy 61, and is just past the Thunder Bay Correctional Centre. We are the first driveway on the right hand side next to Recool Canada Ltd., but still on Highway 61. We are after Little Norway Road, directly across the highway from DeBruin Nursery.

From the US border, we are approximately 46 kms north on Highway 61 towards the city of Thunder Bay. We are the first driveway on the left across the hwy from DeBruin's Nursery.

Please park off the south side of the driveway inside the gate, or north side if outside the gate. We ask that you pick up after your dogs and put the bags in the garbage cans provided. Be sure to bring clothing and things for the weather such as rubber boots and raingear, baggies for poop and scoop, shade and water for your dogs. There are no trees near the arenas.

There will be either a luncheon or concession for the trials. BBQ, snacks and refreshments will be available for sale.

Event Registration Number (ERN)

Foreign born dogs require an ERN to earn CKC titles. This ERN MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "Listed" (fee to be paid with entry); however, failure to apply to CKC for an ERN number within 30 days of the first event WILL result in the cancellation of any wins, awards, or scores. Current ERN fee is \$58.50 + HST.

Performance Event Number (PEN)

A PEN allows an unregistrable dog of a CKC recognized breed to participate in competitive events that are appropriate for the breed. Criteria and eligibility for a PEN number are available on the CKC website. In the case of a foreign born dog residing in the USA, the dog must have been issued an AKC ILP number. A dog that is eligible for a PEN may not be entered as a listed dog. Events may only be entered after PEN has been issued.

Non-Member Participation Fee

Canadian entrants who are not CKC Members: As of January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee. This fee applies only to dogs wholly owned by a non-CKC member, and is not applicable to CKC members or dogs co-owned by CKC members. Non-CKC member participants must either purchase a CKC membership or pay the Non-Member Participation Fee (currently \$57.60 + HST) within 30 days of notification, or awards and titles will be cancelled by the CKC.

RELEASE/WAIVER AGREEMENT

In consideration for participation in these events sanctioned by the Canadian Kennel Club (CKC), I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event. I further agree that I will hold the CKC, its officers, directors, agents and members, the trial giving club (Canadian National Australian Shepherd Association), its officers, directors, agents and members and the owners of the facility (Tanya Wheeler of Tucker Creek Farm) and the stock, harmless and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by or to me or any dog I have entered in or brought to this event. I agree to indemnify the CKC, its officers, directors, agents and members, the trial giving club, its officers, directors, agents and members and the owners of the trial facility and the stock, for any loss, cost or expense including attorneys fees and costs, to which the CKC, its officers, directors, agents or members, the trial giving club, its officers, directors, agents and members and the owners of the facility and the stock, might be subject to as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to the event. RULES

1. The Canadian National Australian Shepherd Association, Tucker Creek Farm, organizers will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume liability in the event of an accident or misfortune, however caused, to either dogs, exhibitors or property. Dogs must be kept under control at all times, and must be kept on leash except when competing.
2. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Herding Trial held under these regulations is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
3. The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC.
4. The listing fee for a dog not registered with the CKC is \$9.49 with entry (includes H.S.T.) A dog must be listed unless it has an individual registration number or an Event Registration Number (ERN) issued by the CKC. Only dogs eligible for registration with the CKC are eligible to compete at these Trials. Failure to obtain an ERN within 30 days of the event will result in any scores being cancelled by the CKC. Application for an ERN can be obtained from the CKC.
5. Only dogs entered in these trials (stockdogs excepted) will be allowed within the precincts of the trial.
6. Exhibitors will be responsible for picking up after their dogs.
7. Water will be available for dogs to cool off in.
8. There is limited shade. Exhibitors are advised to bring their own shade, crates, etc. Food will be available on site and there are also restaurants 2.5 km southeast of the trial site.
9. Exhibitors must sign the waiver form before being allowed to compete.
10. Maximum time allowed for each run will be set by the course director and announced at the handlers' meeting. The course design for each class will be decided upon by the course Director, approved by the judge and posted one hour before the start of the trial.
11. Events will be held rain or shine. Dress for the weather.
12. Exhibitors are solely responsible for the conduct or actions of their dogs while they are on the trial grounds. All dogs must be kept on leash or in crates except when competing.
13. STOCK: Arena Runs will use 3-5 head of sheep/ducks/cattle. Stockdog Trial minimum 10 head of sheep.
