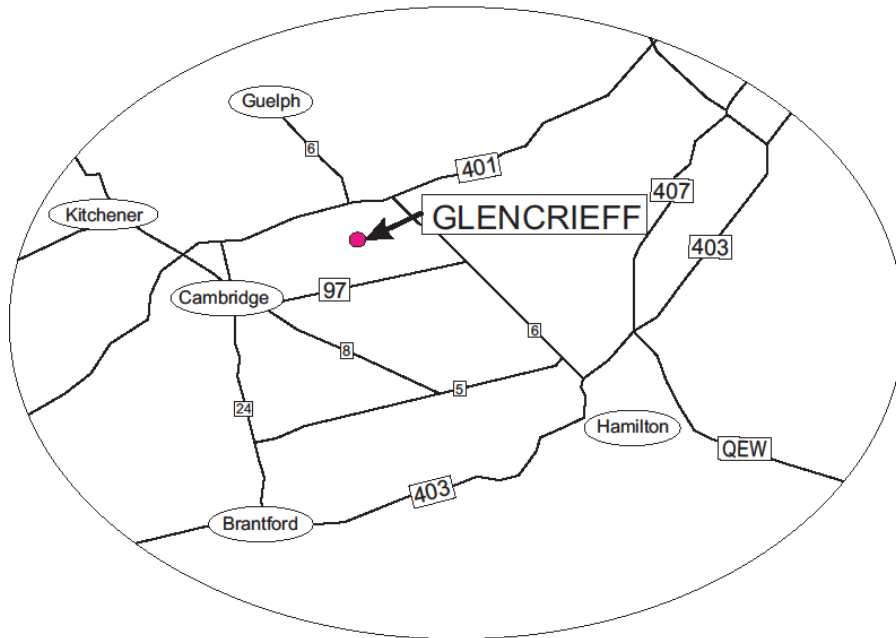

TEST DETAILS:

- Standard CKC Rosettes awarded to all qualifying dogs
- Pigeons and/or game birds will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX. Hunt test handlers shall be attired in dark or customary hunting attire.
- Refunds will be given for Bitches in Season. A Veterinarian certificate must be submitted prior to test
- WCX followed by WCI in each series on Sunday, May 26
- Running order is by random draw within each test level
- Recommended arrival time is ½ hour prior to the start time for each stake.
- Lunches will be available at the headquarters

The Labrador Owners Club is a member in good standing with the Canadian National Master Retriever Club. As of July 1, 2010 only passes at Hunt Tests hosted by clubs in good standing of the Canadian National Master Retriever Club are considered in determining eligibility to enter the National Master Hunt Test Stake.

Entries for WCI or WCX tests, for dogs completing WC or I on the same day, will be accepted until 15 minutes after last WC or WCI stake ribbon presentation respectively.

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011.

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
