

# SOUTH SHORE KENNEL CLUB – JUDGING SCHEDULE

Saturday, June 4 and Sunday, June 5, 2011  
Lunenburg War Memorial Arena, Lunenburg, NS

Judging will begin promptly and adhere as closely as possible to this schedule. **Handlers and exhibitors of several breeds must arrange for alternate handlers should there be a judging conflict. This rule will be strictly enforced. Judges will not wait for any dog or handler delaying a class. Your co-operation is appreciated.**

**Please note:** The figures following the breeds indicate the number of dogs entered in: (1) Male Classes; (2) Female Classes; (3) Specials Only – Male and Female; (4) Total in Breed; (5) Exhibition Only.

Times for Conformation Judging are based on 20–25 dogs/hour. Obedience judging is as follows: Utility – 6 dogs/hour; Open – 7 dogs/hour; Novice A,B,C, & Intermediate – 8 dogs/hour; Pre-Novice – 9 dogs/hour.

**The arena will be open both days at 8:00 am.**  
**Conformation Judging will begin both days at 9:30 am.**  
**Obedience Judging will begin both days at 10:00 am.**

Group judging will follow completion of breed judging within each group. Best in Show, Reserve Best in Show, and Best Puppy in Show will follow all group judging.

**Junior Handling** (Conformation) will be held in the first available ring on Saturday only. **Fee: \$2.00.**

**Please Note:** Set-up time for exhibitors is Friday from **6:00 pm – 8:00 pm.**

**Prong or spike collars will not be permitted at this venue. This is a non-smoking venue.**
