GENERAL INFORMATION

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. *See below for TCN numbers. A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, in the opinion of the judge; they display no signs of physical discomfort and can safely complete the search.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered – Instinct, Novice and Open (Containers, Interior and Exterior). Both trials, limited class entries. Exhibitors CANNOT compete in the same component with multiple dogs. ALL levels will be limited. Move ups will be permitted between trials.

Scent Detection Prize List - Flat ribbons will be given for all qualifying scores. Titling Rosettes will be available. Prizes will be given to the fastest time qualifier in each element, and to the top 3 combined times in each class. The **Maplelane's Diamond Quest (The Questly)** award will be given to the top qualifying dog in the Novice class for Trial #1 (fastest combined time for all 3 elements).

Penalties issued by club - Dropping food while rewarding is considered a contamination. Contamination of the search area will result in a non-qualifying score and any dog who urinates, defecates or vomits within the search area will be excused from the competition.

NSF Cheques

A \$35.00 fee will be applied for tendering of a dishonored cheque for entry fees and shall be considered non-payment of entry fees.

CKC Non-Member Participation Fee / Non-member participation fee /TCN #'s

The new process requires all owners of unregistered, recognized breeds entering events to obtain a <u>Temporary Competition</u> <u>Number</u> (TCN). TCNs will replace the current system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

TCNs will be required to enter all events with closing dates after March 2, 2020.

E toward Belleville. Take ON-401 E to Glen Miller Rd/County Rd 4 in Quinte West. Take exit 526 from ON-401 E. Turn right onto Glen Miller Rd/County Rd 4 (signs for County Road 4 N/Glen Miller Road N). Continue to follow County Rd 4 8.8 km. Turn left onto River Dr/County Rd 33/Regional Rd 33. Continue to follow County Rd 33/Regional Rd 33 11.0 km. Turn right onto W Front St/County Rd 8/Regional Rd 8 800 m. Turn left onto North Street, continue on Stirling Marmora Rd. ON-14/County Rd 14 18.6 km. Turn left onto St Mark's Rd. Turn right onto Claude Rd. At stop sign turn left then right into 724 Huff Rd.

From the East: HWY- 401

West on Highway 401. Follow ON-401 W to Wallbridge Loyalist Rd/Route 1/Regional Rd 1 in Quinte West. Take exit 538. Turn left onto Wallbridge Loyalist Rd/Route 1/Regional Rd 1 Continue to follow Wallbridge Loyalist Rd/Route 1 7.6 km. Turn left onto Foxboro Stirling Rd/County Rd 14/Regional Rd 14. Continue to follow County Rd 14/Regional Rd 14 8.3 km. Turn right onto North Street, continue on Stirling Marmora Rd. ON-14/County Rd 14 (signs for County Road 14) 18.6 km. Turn left onto St Mark's Rd. Turn right onto Claude Rd. At stop sign turn left then right into 724 Huff Rd.
