How to Get to the Test Site -Lot 294475, 8th Line Amaranth, Ontario LON 1G0

From Orangeville:

Head west on 109 (Hwy 9) to 8th Line Amaranth and head North for approximately 13 km. Property on Right.

From Shelburne:

Head west on Hwy 89 to 8th Line Amaranth and head South for approximately 12 km.

Property on Left.

Lunch will be available on site on Saturday and Sunday.

Test Rules

Course and Game:

- FDJ, FD, and FDA will be a single course with bird field.
- FDX and FDXCh will be a single course.
- Chukar will be used in all categories. Ducks/ chukar and/pigeons will be used in the FDX water retrieve.
- Gunning will be done by "official" gunners only.
- FDJ, FD and FDA dogs will be run individually, FDX and FDXCh dogs will be run in braces.
- Handlers must carry a starter pistol, and for safety reasons all entrants must wear blaze orange clothing and blaze orange hat.
- If a dog is not present at its starting point within 5 minutes after it is called for by the judges it may be disqualified.
- Qualifying scores will be available at the end of each test from the Test Secretary.

Other Rules

- No training or running of dogs on the grounds during, before or after the tests.
- Bitches in season are not permitted on the grounds.
- A current record of vaccination may be required.

We expect that everyone attending our tests will behave in a manner that is respectful and appropriate to the dogs, owners, handlers and volunteers. We believe that anyone participating in any of our our field tests should not be subjected to an indignity of any kind during the the test and that it is our duty and obligation to see that this is carried out. If anyone reports an alleged indignity to us, our Field Test Committee will conduct an investigation, make a decision or ruling and then will report to the Canadian Kennel Club. The Discipline Committee of the CKC shall then have the power to take such action as it deems fit.
