Bitches in season are not eligible for entry in the Working Certificate Tests pursuant to Section 6.1.10 of the Working Certificate Test Rules & Regulations.

A separate entry form for EACH DOG in EACH EVENT is required. Move ups to August 25 test only accepted on August 24 by the deadline.

All entries must be accompanied by the entry fee in full. A listing fee of \$8.50 is applicable per dog per event unless the dog's entry carries a CKC individual registration number on the dog being entered or ERN number.

Standard CKC rosettes to all dogs qualifying in each event.

## MAP TO REGINA RETRIEVER CLUB GROUNDS



From Hwy # 1 East: drive 5 km (3.1 miles) east (starting at Peavey Mart). Turn north (left), drive past Cindercrete Products, go across Hwy 46 and keep going till you see the RRC grounds on your left.

From McDonald St (Hwy 46): Drive 6.4 km (4 miles) past Fleet St. Turn north (left) at the Inland sign, keep driving north till you see the RRC grounds on your left.
