As per CKC rules and regulations, it shall be the duty of the test-giving club to see that a judge, club official, steward, volunteer or competitor at a Draft Dog test is not subject to indignities. The Draft Dog Test Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

DRIVING DIRECTIONS TO TEST SITE:

**2628 Road 149, R. R. 7, St. Mary's Ontario N4X 1C9**

(Note: some GPS units prefer the address to be Fullerton instead of St. Mary's)

Driving Directions are from Brantford, Ontario

- Follow 403 West and Merge onto 401 West at Woodstock where 403 ends. Head West on 401 (towards London).
- Just past the service centre on your right take exit 222 to Oxford Road 6/Embros/Stratford.
- Keep right onto Oxford Road 6.
- At the Roundabout go straight onto 37<sup>th</sup> Line/Oxford Road 6 (21.9km).
- As Oxford County changes over to Perth County it becomes Perth 113.
- Just before it changes, you pass through a village called Fairview.
- Stay on 113 for 1.9km. You will pass Camp Bimini and cross a bridge. Your turn will be immediately there.
- Turn left onto Line 20 and go 5.3km to another roundabout.
- At the roundabout go straight onto Perth Line 20 towards Fullerton.
- Follow Line 20 for 6.2 km.
- You will go through St. Pauls. Keep going straight.
- Turn left onto Perth County 130. Go 4.4 Km to Line 15. **Do not take line 16.**
- At line 15, turn right. Go 4.1 km. The road will become gravel.
- Follow line 15 to the checkerboard.
- Turn Left.
- Turn right at next corner and you have arrived.

## General Information and Test Rules:

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Draft Test Regulations are available from the Canadian Kennel Club (416) 675-5511

As per the Draft Dog Test Rules and Regulations, the group option as stated in section 11.2, may be offered at this test.

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Test Secretary after the official closing date as published in the premium list or after the maximum number of entries has been received. If the maximum number of entries is not received, day of entries will be accepted at a fee of \$75.00

No Entry will be accepted unless all particulars called for on the entry form are shown thereon. Incomplete entries will be returned.

No Entry will be accepted unless accompanied by the entry fee. Telephone, fax and email entries cannot be accepted.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellations of any entry after the closing day are prohibited.

The Club reserves the right to refuse any entry, subject to CKC Rules.

Identification and judging schedules will be e-mailed as soon as possible after entries close.

**Eligibility:** Open to all purebred CKC recognized & CKC Miscellaneous breed (MCN), and non-recognized dogs eighteen months of age or older on the day of the event. Every dog entered must be one of the following: Registered with the CKC; have an Event Registration Number (ERN); eligible for registration with the CKC; have a Performance Event Number (PEN); or a Canine Companion Number (CCN). Entries in the Draft Dog Excellent Test must have a CKC Draft Dog (DD) Title. Entries in the Brace Draft Dog Excellent Test must have a CKC Brace Draft Dog Title. The Judges must excuse a dog at any time during a test for lack of physical capacity.

**Entry Limit:** There is a limit of a combination of 10 Draft Dogs/10 Brace Draft Dogs and 5 Draft Dog Excellent/5 Brace Draft Dog Excellent entries which will be accepted on a first come, first served basis.

**Entries:** Entries must be complete, signed & submitted on the official CKC entry form. The order of competing shall be the order that entries are received except that dogs handled by the same person will be separated when possible. No delays will be permitted for handlers entering more than one dog and entrants doing so must have an alternate handler available for the group down exercise if a conflict arises. Re-qualifications will be accepted pending space available. Re-qualifications shall be judged as the last team in the section for which they are entered. After the closing date, mail, email, fax and/or telephone of their entry will notify all entries.

**Bitches in Season:** Bitches in season are allowed to compete but all exercises will be judged after all other dogs have been tested. Bitches in season must be kept away from the test site prior to testing.

**Equipment:** Each entrant to supply his or her own equipment and apparatus. The test committee will supply the freight load. DDX Entrants must provide their own backpacks and backpack weight.

**Test Regulations:** All dogs entered in the Draft Dog Test must go through the basic control exercise, regardless of obedience titles held.

If combination of DDX/BDDX entries has not been received by the closing date these openings may be filled with additional DD/BDD entries. Entry fees will not be refunded after the closing date. If the limit is reached prior to closing date, a list of alternates will be kept to fill any vacancies created due to early (prior to closing) cancellations. Entry fees will be refunded within 10 days following the Test to all withdrawals replaced by an alternate and to all alternates and re-qualifications that did not participate in the test. Email confirmation of receipt of entry will be provided to entrants who provide a valid, legible email address on their entry form.

**Foreign born/ owned dogs:** A dog not individually registered with the CKC may be entered at a test held under these regulations as a "Listed" dog, provided it has an event registration number (ERN) or obtains this from the CKC within 30 days of the first test entered otherwise scores will be cancelled. **Non-member Participation Fee**

- A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
