

- 1. The Show Superintendent will be in full charge of the shows and trials which will be governed by CKC Rules.
- 2. The German Shepherd Dog Club of London will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- 4. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show or trials, no refund of Entry will be made.
- 5. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging.
- 6. Judging will commence at 9 a.m. EST Saturday May 19, 2012. A later starting time may be specified in the judging schedule. Starting time for both conformation and obedience will be specified in the judging schedule.
- 7. No pinch collars will be permitted within the precincts of the Show and Trials. No cover will be provided in case of inclement weather. SHOW PRECINCTS: The Show precincts shall consist of all areas set out for rings, all shelters or facilities set aside for show officials, judges or exhibitors and handlers and 30 feet outside of the judging rings.

Effective January 1, 2012:
